The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and noted the following :-

The Hon'ble Court in W.P. No. 41991/2024 has directed the following :-

*Accordingly, it is ordered that the 4th respondent shall take up Ext.P10 and appropriate orders thereon shall be passed in accordance with law, after hearing the petitioner and the other affected parties, if any. ....*

2. The matter of the institution was considered by SRC in its 450<sup>th</sup> meeting held on 24<sup>th</sup> January 2025 wherein the SRC decided as under :-

- *The authorised representative of the institution be invited to present itself before the SRC in its next meeting for hearing.*
- *The Legal opinion from Legal Consultant of SRC be obtained in this case for further course of action.*

3. In compliance of above order passed by the Hon'ble Court in W.P.No.41991/2024, an email was sent to the institution to represent the case before SRC on 8.2.2025 at 12 p.m. Dr. C.V. Jayashree, Principal of the institution and Mr. Abdul T.P., Secretary of the Managing Committee were present virtually on 08<sup>th</sup> Feb 2025 before the SRC for hearing. The submissions made by the representatives of the institution were heard and after examining the case, the SRC observed that as per NCTE letter F.No.49-3/2016/NCTE/N&S/47143 dated 8.12.2016 & F.No.49-3/2016/NCTE/N&S/47706 dated 26.12.2016, "there is no provision for change of management in the Regulations, 2014 as the change of management of a recognized teacher education institution would amount to commercialization of teacher education". **Therefore, the SRC decided that the request of the institution for change of management is not accepted.**
