The Committee noted that the application of the institution has already been rejected vide letter dated 22.03.2016 on the following grounds:-

 They do not have University affiliated course running 5 years or more. That being so, they will not be eligible to apply for M.Ed. Reject their request.

The institution made a fresh request vide letter dated 18.03.2024 for issuance of Letter of Intent. In this regard, the Committee considered that the decision taken by the 59th meeting of the General Body of NCTE held on 04.12.2023 under Agenda Item No. 4 is relevant and reproduced below:-

"The applications for M.Ed. and M.P.Ed. courses which are returned in light of decision taken by the General Body in its 55th meeting and which are received and pending as on the date of 59th GB Meeting i.e. 04.12.2023 in RCs should be processed further by the Regional Committees for grant of recognition as per norms and standard prescribed by NCTE."

The committee noted that the application of the institution does not fall in the category of "pending" and accordingly is not liable to be considered as per the decision of the GB quoted above.

In view of the above, the Committee decided that the request of the institution made by vide its letter dated 18.03.2024 is hereby rejected.

- 3. It is observed that the faculty list uploaded in PAR is mismatching with the faculty list submitted at the time of issuance of continuation of recognition order. The institution is required to clarify the same.
- 4. The institution is required to submit a latest Fire Safety Certificate issued by Competent Authority.
- 5. The institution has not submitted any supported evidence/photos to establish that building barrier free/accessible.
- 6. From the Performance Appraisal Report (PAR) for the academic session 2020-21, it is observed that the institution has not updated its website as per NCTE Regulations, 2014.

Therefore, the Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act**, **1993** before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 7 days from the date of issue of **Final Show Cause Notice.**
