In view of the above, the SRC decides that permission u/s 15(3) to 2-year B.Ed. course cannot be considered, hence, SRC decided to wait for the final outcome of the Writ Petition filed by the institution

Hence, the institution is not eligible to offer ITEP course for the year 2025-26, as it has obtained less than 10 points.

Therefore, the Committee decided that First Show Cause Notice be issued to the institution to clarify their eligibility for offering ITEP programme thereby providing an opportunity for making written

representation **through online within 21 days** along with all relevant supporting documents from the date of issue of the Show Cause Notice.

The minimum eligibility condition for offering ITEP course is a minimum of 10 points to be shortlisted for processing on the basis of extant norms and standards prescribed by NCTE for offering ITEP course as per Public Notice No. NCTE/Reg1012/1/2024-Reg-Sec-HQ dated 22.04.2024.
- 2. Land document is uploaded by the institution is in the regional language. Translated English version of the land document approved by the competent authority is not submitted/uploaded by the institution.
- 3. As per Building Plan and BCC, demarcated land and built-up area for running ITEP programme is not uploaded by the institution.
- 4. Mutation Certificate is not uploaded by the institution.
- 5. Latest Non-Encumbrance Certificate issued by the competent authority is not submitted.

Therefore, the Committee decided that First Show Cause Notice be issued to the institution to clarify their eligibility for offering ITEP programme thereby providing an opportunity for making written representation **through online within 21 days** along with all relevant supporting documents from the date of issue of the Show Cause Notice.

6. E.G.S. PILLAY COLLEGE OF EDUCATION, THETHI, OLD NAGORE ROAD, NAGORE, NAGAPATTINAM, NAGAPATTINAM, TAMIL NADU-611002.

- 2. The institution has not submitted Mutation Certificate in the online portal.

Therefore, the Committee decided that First Show Cause Notice be issued to the institution to clarify their eligibility for offering ITEP programme thereby providing an opportunity for making written representation **through online within 21 days** along with all relevant supporting documents from the date of issue of the Show Cause Notice.

7. St. Justins College of Education, 161-A, Kamaraja Salai, Madurai – 625009, TamilNadu.

The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

Regarding B.Ed. Programme:-

In obedience of Court order dt. 28.06.2024 passed by the Hon'ble High Court of Madras at Madurai Bench in WP. No. 12622 of 2024 and decided to ask the institution submit written representation along with necessary documents on the following:-

- 1. The institution is to give clarification regarding retaining the number of units and seats annually in B.Ed. course.
- 2. The institution is required to submit latest Non-Encumbrance Certificate.
- 3. The institution has submitted building plan wherein multi-purpose hall size is not reflected.
- 4. The institution has submitted building completion certificate which is not in prescribe format of NCTE.
- 5. The institution is required to submit latest Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognized teacher education programme being run by the institution.)

- 7. The institution is required to submit domain name of the website being run by the institution.

Therefore, the Committee decided to issue **Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents **within 21 days** from the date of issue of **Show Cause Notice.**

Regarding M.Ed. Programme:-

In obedience of Court order dt. 10.06.2024 passed by the Hon'ble High Court of Madras at Madurai Bench in WP. No. 12061 of 2024 and decided to ask institution to submit the written representation along with necessary documents on the following:-

- The institution submitted faculty list which was sufficient only for 1 unit of B.Ed. programme. The institution failed to submit faculty list for 2nd Unit of B.Ed. and M.Ed. programme as per NCTE Regulations 2014. The institution is required to submit latest staf list in the prescribed format duly approved by the Registrar of the affiliating body.
- 2. The institution did not submit form 'A' issued by the bank regarding maintenance of FDRs towards Endowment and Reserve Fund for M.Ed. programme.
- 3. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.

Therefore, the Committee decided to issue **Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents **within 21 days** from the date of issue of **Show Cause Notice**.
