- The recognition of the institution was withdrawn by SRC vide order dated 01.12.2021, as per the decision of SRC in its 404th meeting held on 16th – 17th November, 2021.
- Aggrieved by the order of the SRC, the institution preferred an Appeal and the Appellate Authority vide order No. 89-256/E-279567/2022 Appeal/10th Meeting, 2022 Appeal No.APPLSRC202214261 dated 21.12.2022 confirmed the withdrawal order of SRC.
- The institution approached the Hon'ble High Court of Madras (Madurai Bench) and the Hon'ble Court in WP (MD) No. 20009 of 2004 and W.M.P. (MD) No. 16973/2024 dated 18.10.2024 has directed as under:-
 - 2. Though the said order of the 2nd respondent is challenged on the ground that no opportunity has been given, the learned counsel appearing for the petitioner would submit that as the period of 2022-2023 is already over, in respect of the period of 2024-2025, the petitioner College wants to make a fresh representation for recognition, after complying with all the requirements. Therefore, it would suffice, if the authorities concerned are directed to consider the representation to be made by the petitioner on its own merits.
 - 3.In such view of the matter, the petitioner is directed to give a fresh representation after complying with all the requirements to the 2nd respondent, who in turn, on receipt of such representation, shall consider the same and pass appropriate orders on merits and in accordance with law within a period of two months from the date of receipt of a copy of the application.

The SRC considered the entire matter and decided that as the recognition of the institution has already been withdrawn by SRC and confirmed by the Appellate Authority, the representation submitted by the institution is devoid of merits and disposed off accordingly.

The application of the institution along with other documents attached were scrutinised on the basis of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were considered by SRC and the Committee noted the following: -

- The institution was recognized for B.Ed. course in 2006 for 100 seats and M.Ed. course in 2007 for 25 seats. The Revised Recognition order was issued in 2015 for 2 Units (100 Students) in B.Ed. course and 1 unit (50 students) in M.Ed course.
- The recognition of the institution for B.Ed and M.Ed course was withdrawn by SRC vide orders dated 02.09.2021.
- Thereafter, there were several rounds of appeal to Appellate Authority and writ petitions filed by the Petitioner separately for M.Ed and B.Ed Course and all the Court Orders/Appeal Authority Orders were complied by SRC.
- Thereafter, against the final order of the SRC for B.Ed course, the institution preferred an Appeal before the Appellate Authority of the NCTE. <u>The Appellate Authority vide order concluded to confirm the</u> impugned withdrawal order dated 02.09.2021.
- Further two more writs were filed by the Institution WP 9637/2023 and WP 9203/2023 that directed the Institution to file fresh appeal to appeal authority, NCTE. The Institution filed a fresh appeal before NCTE Appeal Authority only for B.Ed programme and not for M.Ed course.
- Further again the Institution again approached the Court through two different writs WP No. 28294/2023 for M.Ed Programme and WP 28705/2023 for B.Ed programme.
- The Hon'ble High Court of Madras, vide order dtd 05.06.2024 directed the following:

W.P. No. 28705/2023 - B.Ed course

"As far as W.P. No. 28705 is concerned, the Petitioner may well pursue, its appellate remedy and supply a copy of the order of approval dated 12.12.2023 to the appellate authority for consideration, in accordance of Law.

W.P. No. 28294 - M.Ed course

"As far as W.P. No. 28294 is concerned, the Petitioner may apply afresh enclosing a copy of the order of approval as well. Let that application be considered by the respondent, in accordance of Law."

- The institution further approached the Hon'ble High Court of Madras in W.P. No. 34568/2024 and W.M.P. No. 34310/2024 and the Hon'ble Court vide order dated 29.10.2024 has directed the following:-
 - "7. The learned counsel appearing for the first and second respondents submitted that the appeal filed by the petitioner will be decided and appropriate decision will be taken on 11.11.2024.
 - 8. Recording the submission of the learned counsel appearing for respondents 1 and 2, this Court directs the third respondent to allow the petitioner institution to upload the students list for the academic year 2024-2025, subject to decision taken by the first respondent in the appeal preferred by the petitioner."

 The Appellate Authority vide order dated 30.10.2024 has confirmed the withdrawal order of SRC dated 02.09.2021 with regard to B.Ed course.

The SRC after careful perusal of the above facts decided the following :-

- With regard to B.Ed course, the counsel for NCTE may be informed about the decision of the Appellate Authority for further necessary action in the matter.
- With regard to M.Ed course, the institution may apply afresh as and when the NCTE opens the online portal calling for applications for M.Ed course.

The institutions approached the Hon'ble Court of Andhra Pradesh and the Hon'ble Court vide Order dated 1st October 2024 has disposed of the cases with the following direction:-

W.P. No. 18251, 18252, 18254, 18257 and 18263 vide order dated 01st October 2024.

- 11. On careful perusal of the provision that withdrawal of recognition is after giving a reasonable opportunity to such recognised institution. Hence, the contention raised by the institution is acceptable.
- In view of the provision appended to Section 17 (1) of the Act, 1993, the respondents invariably have to issue a notice before de-recognising the institution.
- "13. As there is a dispute with regard to the issuance of show cause notice, the 3rd respondent is hereby directed to issue a fresh show cause notice to the petitioners-institutions calling for explanation and, on receiving such show cause notice, the petitioners-institutions are hereby directed to submit explanation. On receiving such explanation, the 3rd respondent shall pass appropriate orders in accordance with law, as contemplated under the Act 1993 and communicate such decision to the petitioners-institutions......"

In compliance of the order dated 01st October 2024 passed by the Hon'ble High Court of Andhra Pradesh in W.P. No. 18251, 18252, 18254, 18257 and 18263, the case was considered by SRC and the SRC decided that Review application / Appeal against the above order dated 01.10.2024 be filed by SRC on the following grounds:-

- In all above cases, the SRC-NCTE has already withdrawn recognition of the institution (s) after following due procedure as laid down in the NCTE Act, 1993 and the Regulations & SOP made thereunder.
- There is no provision in the NCTE Act Rules and the Regulations whereunder Show Cause Notice u/s 17 of the NCTE Act, 1993 may be issued to an Institution which recognition is already withdrawn by the Regional Committee.
- Moreover, it is noted that the petitioner approached directly to the Hon'ble Court without exhausting the alternative remedy of filing Appeal under Section 18 of the NCTE Act, 1993.

The Recognition of the above institutions (Sr. No. 69-72) was withdrawn by SRC after following due procedure as laid down in the NCTE Act and the Regulations & SOP made thereunder.

The institutions approached the Hon'ble Court of Andhra Pradesh and the Hon'ble Court vide Order dated 1st October 2024 has disposed of the cases with the following direction:-

W.P. No. 18253, 18256, 18258 and 18261 vide order dated 01st October 2024.

- The impugned order dated 27.03.2023 came to be passed in exercise
 of power conferred under Section 17 of the Act by the 3rd respondent
 withdrawing the recognition granted to the petitioners institutions for not
 submitting reply for the show cause notices dated 02 & 03.03.2023.
- 9. The Court holds that simply directing the petitioners-institution ns to submit explanations in response to the final show cause notice dated 02&03.03.2023 does not contravene any provisions of law, nor does it extend the limitation period set by the Limitation Act. Even if the impugned order is considered as final, the remedy sought by the petitioners should

be assessed on merits without disregarding the issue of offering explanation belatedly.

10. Hence, the petitioners in all the Writ Petitions are directed to submit/offer their explanation to the show cause notice dated 02&03.03.2023 within a period of four (4) weeks from the date of receipt of a copy of this order, on receiving such explanation for the show notice dated 02&03.03.2023, the 3rd respondent is directed to consider and examine the explanation and pass appropriate orders hereon, in accordance with the provisions of the Act 1993 and communicate the decision to the petitioner-institution within a period of eight (8) weeks there from."

In compliance of the order dated 01st October 2024 passed by the Hon'ble High Court of Andhra Pradesh in W.P. No. 18253, 18256, 18258 and 18261 the case was considered by SRC and the SRC decided that Review application / Appeal against the above order dated 01.10.2024 be filed by SRC on the following grounds:-

- In all above cases, the SRC-NCTE has already withdrawn recognition of the institution (s) after following due procedure as laid down in the NCTE Act, 1993 and the Regulations & SOP made thereunder.
- There is no provision in the NCTE Act Rules and the Regulations whereunder Show Cause Notice u/s 17 of the NCTE Act, 1993 may be issued to an Institution which recognition is already withdrawn by the Regional Committee.
- Moreover, it is noted that the petitioner approached directly to the Hon'ble Court without exhausting the alternative remedy of filing Appeal under Section 18 of the NCTE Act, 1993.
