The institution shall be required to submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details (i) Details of land & building available at the time of recognition with the Institution (ii) Details of land & building now available with the Institution (iii) Status of Management at the time of recognition and its present status
In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the SRC, NCTE.

	Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of
	NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned
	above to the institution. The institution is required to submit the documents within
	21 days from the date of issue of Final Show Cause Notice.
