The Committee also made the following resolutions:-

- (a) The Committee thoroughly deliberated upon the issue of existing continuation of recognition to all the Govt. Colleges in Tamil Nadu. It is observed that the Govt. institutions are running since last couple of years without sufficient strength of faculty members. In order to make quality in teacher education human resource plays a vital role. As the appointment procedure in Govt. requires some more time, keeping in view the same the Committee has given the ample time to the authorities with a request to provide the required number of faculty members.

Even after repeated requests, it is observed that there is no much improvement in this regard. Therefore, the Committee decided to request the authorities in the Department of Education, Govt. of Tamil Nadu to address the issue of providing the teaching faculty to all the Govt. colleges of Teacher Education immediately.

Therefore, the Committee resolved to write to the Education Secretary, Govt. of Tamil Nadu with a similar request to comply with the teaching staff requirement as per NCTE norms within 90 days till then the admissions for the academic session 2020-2021 be deferred.

- (b) The Regional Director, SRC, NCTE apprised the Committee about the mentioning of session for withdrawal of recognition from the academic year 2020-2021. The Committee observed that the decision of the SRC is in the line of provisions of the NCTE Act, 1993 as due to the COVID 19 pandemic the session 2020-2021 has not yet commenced as such the withdrawal of recognition will be effective for the academic session i.e. 2020-21.
- (c) The Committee noted that reconsideration of RPRO matters which are accorded recognition before promulgation of Regulations 2014 has been undertaken by SRC and being considered in every meeting to verify the veracity of the institution who have complied with the Regulations 2014.

Further, the Regulations 2014 was amended on 09.06.2017 regarding staff eligibility. Some of the States have reported violations by the institutions with regard to admissions, not obtaining Affiliation etc.

Keeping in view the comprehensive scrutiny of institutions and also in view of further amendments of Regulations 2014, the matters were discussed by SRC and it was decided to ensure that all the recognized institutions are conforming to the Norms and Standards set by NCTE Regulations 2014.

In this regard, the Committee directed the Regional Director, SRC to issue a Show Cause Notices u/s 17 of NCTE Act, 1993 to all the institutions wherein Recognition was accorded by the SRC under Regulations 2014 with the direction to submit all requisite documents coupled with latest approved Staff list from concerned affiliating bodies. In case no reply or part reply to SCN is received by the SRC office. The RD is also authorised to issue Final SCN in all such matters.

- (d) The Committee noted that there are number of RPRO pending cases where SCN/FSCN has not been issued so far as per decision taken in its 381<sup>st</sup> meeting in the RPRO matters. The Committee, therefore, directed the Regional Director, SRC to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points format viz a viz the information about status of land & building/shifting from rented premises/management etc.

In case where RPRO not issued due to non-submission of Affidavit, the Regional Director, SRC is also directed to issue Show Cause asking the institution to submit its explanation for non-submission of Affidavit giving consent to come under NCTE Regulations, 2014 viz a viz to submit all the required documents as per the 13 points format viz a viz the information about status of land & building/shifting from rented premises with processing/ status of management etc.

In case where original files/records are not traceable due to shifting of office premises from Bangalore to Delhi, in such a cases the Regional Office shall also issue a SCN asking them to submit a copy of papers related with its application up to the issuance of FR along with latest status of affiliation and all the required documents as per the 13 points format

- (e) The Committee noted that the institutions are submitting processing fees towards inspection fee for shifting of premises without requisite documents as per NCTE Regulations, 2014. In these cases, before processing such matters and accepting the fee. The SRC office shall ask the institution to submit all the requisite papers and after acceptance of the same by the SRC satisfactorily such matters shall be further processed by the SRC office.

The Committee also directed that the RD, SRC to issue SCN/FSCN in all matters related with the institutions which has been running on rented premises and not yet shifted to permanent building.

- (f) The Committee noted that the SRC office written a letter to the Registrar, Acharya Nagarjuna University vide letter No. SRO/NCTE/Complaint/2019/10282-284 dated 9<sup>th</sup> Oct., 2019 regarding fraudulent orders submitted by the non-

recognised institutions. The Principal Secretary (Higher Education) was also informed by the SRC, NCTE vide letter No. SRO/NCTE/Complaint/2019/110692 dated 17<sup>th</sup> Oct., 2019. The Principal Secretary (Higher Education) was also reminded by the SRC office vide letter No. SRO/NCTE/Complaint/2020/114625 dated 12<sup>th</sup> Feb., 2020. However, the SRC has not received any response in the matter so far.

The Committee directed the RD, SRC to send a reminder letter to the State Govt. authorities in the matter so as to ascertain action taken on the errant non-recognised institutions and also write a letter to the concerned DGP, Andhra Pradesh to enquire into the matter as to how the non-recognised institutions without valid recognition of the NCTE approached the Acharya Nagarjuna University on the basis of fake & fraudulent recognition order for getting the affiliation of the affiliating University.
