The Committee resolved the following:-

1. It is resolved that the matters with respect to **ODL (Open Distance Learning)**, a Sub-Committee was constituted by the SRC, the Sub-Committee has recommended to collect Rs. 2 Lakhs from each institution for getting the self-

learning material evaluated by the subject experts from the across the country alongwith other recommendations.

In view of the long correspondence that took place between UGC (DEB) and SRC, NCTE about establishing the validity of the SLM submitted by the Universities offering B.Ed. (ODL), after thorough deliberations in the SRC meeting, the SRC decided to constitute a Sub-Committee under intimation to the NCTE Hqrs. The Sub-Committee made several recommendations on the matter. The same recommendations were placed before the SRC and SRC approved the same. The then Regional Director, SRC implemented the recommendations. The collecting of processing fees is one such recommendation which will enable the SRC to make the payment to the experts who evaluated the SLM. The similar practice was also followed by UGC (DEB) earlier when they have undertaken the responsibility of getting SLM evaluated.

In view of the above, the Regional Committee resolved to request the NCTE Hqrs. to ratify the action taken by the RD, SRC in this regard.

2. The Committee further resolved that in case the SRC has taken a decision for closure/withdrawal of the recognition granted to the institution, in all such cases the Regional Director, SRC is advised to issue NOC or return the original FDRs, if any to the respective institution after taking an Affidavit on Rs. 100/- non-judicial stamp paper stating the following duly notarised: -

- (i) The institution has not challenged the withdrawal order issued by the SRC either before Appeal Committee or any Hon'ble Courts.
- (ii) An undertaking stating that no dues either salary or any other arrears payable to teaching and non-teaching staff.
- (iii) A copy of NOC issued by the Affiliating body/University as applicable.

The institution has applied for NOC to the Affiliating body/University, however, if they have not issued NOC within 2 months against your request enclose the documentary evidence for the same.

3. The Committee further discussed in detail the salary paid to the teacher educators working in the self-financing teacher education institutions is very meagre. In view of the same the Committee resolved to request the NCTE Hqrs. to apprise the same to the respective State Govts. and also suggest them to increase the tuition fees for different teacher education programmes in view of the NCTE Regulations in vogue.
