	The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: - In Obedience of Court Order dated 26.03.2024 in WP No. 3544 of 2024 by Hon'ble High Court of Andhra Pradesh, the SRC committee considered the matter along with the representation made by the Institution dated 10.09.2024 and decided to issue Show Cause Notice to the Institution on the following grounds:- 1. The institution is required to submit latest Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff

The institution is required to submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014. 7. 	<p>Show Cause Notice dated 11.09.2024, the SRC Committee has observed that, despite explicit requests for the submission of the latest and consolidated faculty list in both the First Show Cause Notice and the Final Show Cause Notice, the Institution has repeatedly provided the faculty list which was approved on different dates by the affiliating body. Also, the faculty approved list is very old. The institution vide FSCN dated 11.09.2024, was specifically directed to submit the latest approval of faculty issued by the affiliating body but the institution failed in submission of the same. The representatives of the institution were also unable to provide/explain the reasons before the committee.</p> <p>Therefore, the SRC Committee has resolved to grant a last opportunity for the Institution to submit the following documents:-</p> <ol style="list-style-type: none"> 1. Consolidated and updated Faculty List, duly approved by the competent authority. 2. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority. 3. Proof of construction of Ramp with all facilities for the convenient use of physically impaired.

(2 years) programme in the Department of Physical Education and Sports, Central University of Tamil Nadu, Neelakudi, Thiruvarur, Tamilnadu from the academic session 2024-2025.</p> <p>The Registrar, Central University of Tamilnadu had submitted an application seeking grant of recognition of M.P.Ed. (2 years) programme in the Department of Physical Education and Sports, Central University of Tamil Nadu, Neelakudi, Thiruvarur, Tamilnadu from the academic session 2024-2025 through offline mode.</p> <p>Further, Prof. M.Krishnan, Vice Chancellor, Central University of Tamilnadu drawn the kind attention of the Secretary, Department of School Education, MoE, Govt. of India vide letter dated 25.07.2024 and requested as under :-</p> <p><i>“As the only Central University in Tamil Nadu, dedicated to launching the M.P.Ed. programme within a multidisciplinary environment as envisioned by the NEP 2020, and considering the pressing demand for physical education teachers and coaches in various sports disciplines, the Central University of Tamil Nadu requests the Ministry of Education to recommend NCTE to consider our application under Section 12 of NCTE Regulation 2014 as a special case in the larger public interest.”</i></p> <p>As stipulated under clause 6(3) of NCTE Regulations, 2014 <i>“the application shall be submitted electronically alongwith the processing fee and scanned copies of required documents such as no objection certificate issued by the concerned affiliating body...”</i> The Committee noted that the instant application has been received offline and without processing fee.</p>

	<p>The Committee further deliberated upon the provision of clause 12 of NCTE Regulations, 2014 which provides the following :-</p> <p><i>“On the recommendations of the Central Government, or State Government, or Union Territory Administration concerned, or in cases of removal of any hardship caused in adhering to the provisions in these regulations, keeping in view the circumstances peculiar to the said Governments or Union territory, it shall be open to the Chairperson, for reasons to be recorded in writing, to relax any of the provisions of these regulations, in respect of any class or category of institutions, in the concerned State or Union Territory, or of Central Government institutions to such an extent and subject to such conditions, as may be specified in the order and decisions shall be brought to the notice of the Council in the next meeting. IN exceptional cases and for reasons to be recorded in writing, the Chairperson, shall be competent to relax any of the provisions of these regulations and the related norms and standards subject to its ratification by the Council.”</i></p> <p>In view of the above, the SRC decided to forward the matter along with application and annexures to the Hon’ble Chairperson, NCTE for consideration under Clause 12 of NCTE Regulations, 2014.</p>

A.P. regarding change of affiliating body as Andhra Kesari University, Ongole, Prakasam, A.P.</p> <p>The Registrar, Andhra Kesari University has forwarded a letter No. AKU/NCTE/Affiliating University/Change/2024/3 dated 21.09.2024 and stated that the Andhra Kesari University, Ongole was established by Act No. 21 of 2021 of Andhra Pradesh Universities Act, 2021. In this context, the Registrar has submitted the request to change the name of Affiliating University for Education and Physical Education Colleges in erstwhile Prakasam District as Andhra Kesari University in NCTE.</p> <p>The Registrar has forwarded a list of 110 Colleges in respect of B.Ed. Colleges and 9 institutions in respect of B.P.Ed. Colleges. As per the Public Notice F.No.NCTE-Reg1022/16-2023-Reg.Sec-HQ dated 5th February, 2024, transition from the 4- year integrated programme (B.A. B.Ed./B.Sc. B.Ed.) to the integrated Teacher Education Programme (ITEP) prescribed in NCTE (Amendment) Regulations, 2021, shall be permitted only in the multidisciplinary institution. Further it is stated in the public notice dated 05.02.2024 that, the institutions shall be allowed to admit students up to the academic year 2024-2025. No fresh admissions shall be made in this course thereafter. The 4-year integrated B.Sc. B.Ed./B.A. B.Ed. programme under the omitted Appendix-13 shall be discontinued from the academic session 2025-2026. In view of the above observations, the Committee decided to reject the application of the institution for transition from B.A./B.Ed./B.Sc.
