The SRC noted the Action Taken Report of 451st meeting of SRC held on 08th February 2025.

1.	Consideration of ODL Cases
	The matter regarding Distance Education / ODL courses being offered by Universities under the purview of SRC was considered by SRC and the SRC noted the following :-
	1. The SRC in its 444th meeting held on 15th – 16th October, 2024 considered the matter of Universities offering ODL Courses and resolved to direct the RD, SRC to seek information from the University Grants Commission – Distance Education Bureau (UGC – DEB) regarding the approval status of the Self Learning Materials (SLM) used in the B.Ed. (ODL) programme offered by the above 15 institutions. Further action in this matter would be taken on receiving the said information from UGC - DEB, in

accordance with the NCTE norms and regulations.”

2. Accordingly, as per the decision of SRC a letter was issued by RD-SRC to the Chairman, University Grants Commission on 12.02.2025.

3. The entire matter was considered by SRC in its 452nd meeting held on 24th February 2025 and the SRC decided as under :-

The office may place the entire matter before the SRC in its meeting scheduled for 27th February 2025 detailing therewith the list of Universities which have submitted the approval letter from Distance Education Bureau (DEB) for Self Learning Materials (SLM) used by B.Ed (ODL) programme offered by the following 14 Universities/ Institutions.

4. The UGC-Distance Education Bureau on its website has uploaded the two circulars wherein the list of institutions recognised to offer Open and Distance Learning (ODL) Programmes for the academic year 2024-2025, session October, 2024 (revised from July-August 2024) has been mentioned. From the document so uploaded by UGC-DEB, the following Universities / Institutions are recognised to offer B.Ed (DE) programme for the academic session 2024-2025.
