



253.4.8 Consideration of Complaints received from Madhyamik Shiksha Mandal, Bhopal against the Colleges in Gwalior district

The WRO received complaint from Madhyamik Shiksha Mandal, Bhopal against the Colleges located in Gwalior which was considered by the WRC in its 229th meeting held on July 21-22, 2015. The Committee had decided that "the complaint be put up with recognition status of 39 institutions mentioned in the letter for consideration."


The matter was again considered by the WRC in its 231st meeting held on August 25-26, 2015. The Committee decided that "the institutions figuring in the list provided by the Madhyamik Shiksha Mandal be verified from the records whether the inspection of the institutions was carried out by the Collector, Gwalior earlier and after verification, detailed note be submitted for consideration."

It was found by the WRO from the records that the inspections were not conducted by the Collector, Gwalior earlier.

The Collector, Gwalior vide letters dated 23/11/2015 and 16/12/2016 forwarded the reports of inspection to the office of Lokaayukt, M.P. which were forwarded to Madhyamik Shiksha Mandal vide their letter dt. 15/03/2016. Madhyamik Shiksha Mandal forwarded the copy of reports to the WRC for action against the institutions.

The Complaints have been received regarding six institution in Tikamgarh district, from:

- 1. Shri, Brijendra Singh Rathore, Former MLA, Vidhansabha, Bhopal;
- 2. Shri Ganesh Singh, Member of Parliament, New Delhi; and
- 3. President, Nagar Plaika, Niwadi, Dist. Tikamgarh, M.P.

It was found that all the three complaints are word to word same and all three have been posted from T.T. Nagar Post Office, Bhopal. The complaint mentions that six institutions have been given recognition by the WRC, whereas only two of them have been recognized and the rest are in process. The above observations raise a doubt about the genuineness of the complaints. Therefore, as a preliminary step, a copy of the letters be sent to the respective complainants to get confirmation about genuineness of the complaint.

Any other Item:

The WRC while granting recognition for 2016-17 noticed that the institutions submitted the staff profile approved by the affiliating body within a short period of issue of the letter of intent. WRC, has, therefore, decided that in all cases in which recognition has been given for the academic session 2016-2017, a copy of the staff list submitted by the institution be sent to the concerned affiliating body to verify the signature and seal of the approving authority giving 30 days time. Similarly, a copy of the CLU(s), copy of the Minority Certificate in case of Minority institutions and a copy of the NOC of the affiliating body be sent to the Issuing Authorities for authentication giving 30 days time.

The cases after expiry of a period of 30 days may be placed before the WRC for consideration and decision.
