THE NATIONAL COUNCIL FOR TEACHER EDUCATION ACT, 1993

No. 73 or 1993

[29th December, 1993.] An Act to provide for the establishment of a National Council for Teacher Education with a view to achieving planned and co-ordinated development of the teacher education system throughout the country, the regulation and proper maintenance of norms and standards in the teacher education system and for matters connected therewith.

BE it enacted by Parliament in the Forty-fourth Year of the Republic of India as follows:-

CHAPTER I

PRELIMINARY

1. (1) This Act may be called the National Council for Teacher Education Act, 1993.

(2) It extends to the whole of India, except the State of Jammu and Kashmir.
