PUBLIC NOTICE

The National Council for Teacher Education is a statutory body that came into existence in pursuance of the National Council for Teacher Education Act, 1993 (No. 73 of 1993) on the 17th August, 1995 to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of Norms and Standards in the teacher education system and for matters connected therewith.

2. As part of one of the conditions of recognition, NCTE insists on the submission of a Performance Appraisal Report annually which includes an annual statement of accounts duly audited by a Chartered Accountant. Similarly, in section 12(j) & (k) of the NCTE Act, 1993, the following is mandated-

“(j) Examine and review periodically the implementation of the norms, guidelines and standards laid down by the Council, and to suitably advise the recognised institutions;

“(k) Evolve suitable performance appraisal system, norms and mechanism for enforcing accountability on recognised institutions;”

3. In view of the above, in accordance with the decision taken by the General Body of the Council in its 61st meeting held on 5th August 2024, all the existing Teacher Education Institutions (TEIs) were directed to submit year-wise Performance Appraisal Report(s) (PARs) for the Academic Session(s) 2021-22 & 2022-23 on the NCTE portal (<https://ncte.gov.in/par/>) through online mode during the period from 09.09.2024 to 31.12.2024 (till 11:59 pm).

4. In this regard, all the existing Teacher Education Institutions (TEIs) are hereby informed that Show Cause Notice(s) under Section 17(1) of the NCTE Act 1993 is/are being issued, to the institutions that have not filled up the PAR, by the Regional Committee(s) concerned, on the address/email of the institution(s) available with the office of Regional Committee(s) concerned to submit their reply within a period of 15 days through online mode only on the NCTE web-portal (https://par.ncte.gov.in/par_feedback_system/). All concerned are hereby advised to submit their reply to the Regional Committee(s) concerned accordingly.

5. NCTE will also initiate the scrutiny of data of those institutions that have submitted the PAR and action taken in this regard will be informed to them in due course separately.
