O R D E R

Having heard the learned senior counsel Mr. Ranjit Kumar, learned counsel Mr. Sanjay Sharawat and Mr. Amitesh Kumar appearing for the respective petitioners and the learned Solicitor General Mr. Tushar Mehta with learned counsel Ms. Manisha T. Karia appearing for the respondent in caveat, we are not inclined to consider interference in the impugned common order dated 25.02.2022 passed by the High Court of Delhi in the batch of matters led by LPA No. 190 of 2021. These petitions are, therefore, required to be dismissed.

However, it is noticed that the High Court, while declining interim relief, had granted time until 31<sup>st</sup> March, 2022 to the respective institutions to furnish their appraisal report. The matters have been considered today and we are declining to interfere but looking to the totality of circumstances, the time for compliance is extended until tomorrow i.e., 2<sup>nd</sup> April, 2022.

Subject to the relaxation foregoing, these petitions stand dismissed.

All pending applications stand disposed of.

The learned Solicitor General assures that the requisite steps for facilitating compliance by the respective institutions shall be taken by the respondents, including opening of the portal until mid-night tomorrow i.e., 2<sup>nd</sup> April, 2022.
