Please find enclosed herewith the copy of order dated 09.11.2022 passed by the Hon'ble High Court of Delhi in WP No. 3299/2017 in the batch matters of 'NOC', wherein the Hon'ble High Court of Delhi given the following directions.

"1. The petitioners in these cases have challenged Regulation 5(3) of the National Counsel for Teacher Education (Recognition Norms and Procedure) Regulations, 2014 and the instructions issued by respondent no.1 to the extent that the same require submission of a 'No Objection Certificate' by the affiliating body.

2. The learned counsel for the petitioners state that respondent no.1 at its 54th and 55th meeting have decided not to permit the courses in respect of which the petitioners had sought the aforesaid relief. He states that as it stands today, the substratum of these petitions does not survive. He, however, states that the decision of respondent no.1 taken at its 54th and 55th meeting are subject matter of challenge in two proceedings: one before the Division Bench of this Court [W.P.(C) 9708/2022] and one before the learned Single Judge [W.P.(C) 12983/2022]. He states that if the petitioners succeed in those petitions, then the petitioners' grievance in the present petitions would require to be considered."
