

Dear

The National Council for Teacher Education (NCTE) was set up by an Act of Parliament (No. 73 of 1993) with a view to achieving planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of norms and standards in the teacher education system and matters connected therewith.

In the light of directions contained in the order dated 15.11.2016 of the Hon'ble High Court of Patna in CWJC No. 9230/2016 Dr. B.R. Ambedkar College of Education Vs The State of Bihar & Others, inspections of all Teacher Education Institutions, including Universities, government and private institutions which run teacher educational courses in the State of Bihar by especially constituted teams has to be concluded in a time bound manner.

The inspection of these Institutions is to be restarted after summer vacations i.e. from 1st week of July, 2017 onwards.

NCTE has decided as a matter of policy that all TEIs will need to seek accreditation from the NCTE appointed agency, once every 5 years and within 12 months of the notification date 28.04.2017.


Furthermore, NCTE has been working towards identifying quality TEIs, as also attempting to pin point substandard or non-compliant TEIs with a view to withdrawing recognition. Towards this end an affidavit was prescribed and mandated to be submitted by all TEIs. Non-filers were issued with a Show Cause Notice and thereafter given one more opportunity to fill up the online Proforma of the mandatory affidavit vide Public Notice dated 17.06.2017. 
In order to implement the Honøble Patna High Courtøs order in letter and spirit, NCTE will be conducting the inspections using the accreditation format to enable submission of a quality report before the Honøble Patna High Court.

Accordingly the following aspects may be noted by each TEI for compliance: -

- (1) All TEIs must access the affidavit portal to validate the data placed therein. This is necessary for even those TEIs who have filed the affidavit in 2016 or replied to Show Cause Notice in 2017. To submit the Mandatory Affidavit please visit NCTE website www.ncte-india.org sub-head Affidavit for TEIs.
- (2) To immediately register on the relevant link on the NCTE Portal after paying the requisite fee.
- (3) It would be in the interest of TEIs to avail of an opportunity to interact with Chairperson NCTE during the course of a workshop with the following details:
