

Modalities & Terms of Reference (ToR) for engagement of above consultants:

1. The candidates on his/her selection shall be given an Offer of Engagement and on acceptance of the offer, he/she shall enter into a contract with the National Council for Teacher Education, detailing the terms and conditions of engagement, also with a confidentiality clause before being assigned any work.

2. General conditions:

- He/she will be engaged for fixed period for providing high quality services within given timelines.
- Persons with requisite qualification and experience as prescribed would be hired on selection as Consultant.
- The initial tenure of engagement for a person as Consultant would be 6 months from the date of joining. Extension after 6 months will be considered on need basis and performance based with the approval of Competent Authority.
- He/she will be appointed on full time basis and would not be permitted to take up any other assignments during the period of engagement with National Council for Teacher Education.
- The candidate selected as Legal Consultant shall acknowledge and agree that in consideration of their employment with the NCTE, he / she will not initiate or be associated in any legal action, lawsuit against NCTE in the matters challenging any order passed, decision taken, or notification issued by General Body of the NCTE, NCTE Hqrs. or Regional Committees of the NCTE for the period of next two years from the date of his / her completion of tenure / resignation / premature termination.

3. Procedure for Selection:

The Selection of candidate will be made on the basis of walk-in-interview and as per order/guidelines on the subject. NCTE reserves the right to increase/decrease the number of posts or cancel this advertisement as per requirement.

4. Conflict of Interest:

The selected candidates shall be expected to follow all the rule and regulations of the Govt. of India as applicable and any situation of conflict of interest shall be discussed. He/ She will be expected to display utmost integrity, confidentiality of office matters and sincerity while discharging duties. In case his/her services is not found to be satisfactory or found in conflict with the interests of the Government, his/her services will be liable for discontinuation without assigning any reason.

5. Termination Notice:

- i.
