CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, **Shri Vijay Chandrashekara College of Education, Kurubnal Road, Kushtagi, Koppal District, Karnataka-584121** run by **Sri Vijayachandrasekhar Educational & Rural Development Trust, Kushtagi, Koppal District, Karnataka-584121** vide SRC order No. F.SRO/NCTE/B.Ed./2008-2009/3730 dated 11.08.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2008-2009.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 23.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 15.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its meeting held on 22nd October, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause was issued to the institution on 10.10.2019. The institution has submitted reply on 21.11.2019.

4. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*The Committee on perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Shri Vijay Chandrashekara College of Education, Surver No. 100/2, Kurubnal Road, Kushtagi, Koppal District, Karnataka-584121** for B.Ed. programme for 2 basic units of 50 students each."*

5. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Shri Vijay Chandrashekara College of Education, Survey No. 100/2, Kurubnal Road, Kushtagi, Koppal District, Karnataka-584121** run by **Sri Vijayachandrasekhar Educational & Rural Development Trust, Survey No. 100/2, Kurubnal Road, Kushtagi, Koppal District, Karnataka-584121** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **2 basic units of 50 students each** subject to fulfilment of the following conditions: -
