WHEREAS, the recognition was granted to the institution namely Fathima Memorial Training College, Pallimukku, Kollam 691010 Kerala Pradesh for B.Ed.-Al, M.Ed. & ELE as per following details:-

- (i) The SRC vide Order No. F.KL/ELE/N/27/SRO/NCTE/2004-2005/4567 dated 05.07.2004 for Elementary course of two-years duration from the academic session 2004-2005 with an annual intake of 50 students.
- (ii) The SRC vide Order No. F.No.SRC/NCTE/2009/B.Ed.-Al/RO/13335 dated29.05.2009 for conducting B.Ed. (Addition intake) course of one-year duration with an annual intake of 200 students and an additional intake of 100 students.
- (iii) The SRC vide Order No. F.No.SRO/NCTE/KL/2009-2010/16100 dated 15.10.2009 for conducting M.Ed. course of one-year duration with an annual intake of 25 students from the academic session 2009-2010.
- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 31.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 (one basic unit 50 students) and B.Ed. programme of two years duration with an annual intake of 100 (two basic unit 50 students each) from the academic session 2015-16.
- **4. AND WHEREAS,** the matter was again placed before SRC in its 377th meeting held on 03rd & 4th July 2019 wherein the flowing decision issue Final Show Cause Notice u/s17 of NCTE

Act. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 24.07.2019. In response, the institution submitted its written representation on 19.08.2019.

5. **AND WHEREAS,** the matter was placed before SRC in its 382^{nd} Meeting held on 26^{th} - 27^{th} November 2019, and the Committee decided to issue Final Show Cause Notice. Accordingly, as per

decision Final Show Cause Notice was issued to the instruction on 19.10.2020. the institution has submitted reply to final show cause notice on 19.11.2020.

6. AND WHEREAS, The matter was placed before SRC in its 383^{rd} Meeting held on 07^{th} - 09^{th} January 2019, and the Committee decided as under:-

"The Committee noted that the institution has earlier submitted its reply vide letter dated 19.8.2019 which need to be considered by the SRC. The matter be placed in the next meeting with detailed agenda note."

7. AND WHEREAS, the matter was further considered by the SRC in its 405th meeting held on 13th – 14th December,2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 19.08.2019, 24.12.2019, 03.01.2020 and 05.10.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted staff list of 10 faculty for B.Ed., M.Ed. and D.El.Ed. Programme. The faculty strength is not sufficient to run these courses as per the minimum requirement laid down under NCTE Regulations, 2014. The institution failed to submit latest Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format as per provisions of the NCTE Regulations, 2014.
- 2. The institute has submitted the form 'A' for one programme only. The institution is not maintaining Endowment and Reserve Funds for all programms as required under NCTE Regulations, 2014.
- 3. The Building Plan submitted by the institution is not readable. Moreover the size of Multipurpose Hall is not mentioned in the building plan. The building plan is also not approved by the competent authority.
- 4. The institution did not submit details of administrative and professional staff as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014 for B.Ed. course.
- 5. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 6. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Fathima Memorial Training College, Pallimukku, Kollam 691010 Kerala for conducting B.Ed., M.Ed. & Elementary programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

8. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Fathima Memorial Training

College, Pallimukku, Kollam 691010 Kerala for conducting B.Ed. Programme of two-year duration with an annual intake of 100 students (two basic units), M.Ed. programme of two years duration with an annual intake of 50 (one basic unit 50 students) and *Elementary* programme of two-year duration with an annual intake of 50 students (one basic unit) with effect from the academic session i.e. 2022-2023 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
