WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Sri Ganesh D.Ed. College, Attibele, Hosur Road, Anekal Taluk, Bangalore, Karantaka-560107** was granted recognition vide SRC (NCTE) order no. F.No.SRO/NCTE/D.Ed./2006-2007/7191 dt.10.08.2006 for conducting Elementary D.Ed. Course of two and half years duration with an annual intake of 50 students from the academic session 2006-2007.

2. **AND WHEREAS**, the SRC in its 253rd Meeting held on 30th September & 01st October, 2013 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 18.12.2013. The institution did not submit reply to the Show Cause Notice.

3. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not replied to the Show Cause Notice dated 18.12.2013.

*Hence, the Committee decided to **withdraw the recognition** granted to **Sri Ganesh D.Ed. College, Attibele, Hosur Road, Anekal Taluk, Bangalore, Karantaka-560107** for conducting **D.Ed. programme** with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".*


4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition **Sri Ganesh D.Ed. College, Attibele, Hosur Road, Anekal Taluk, Bangalore, Karantaka-560107** run by **Sree Murugesh Educational Trust, Bangalore, Karnataka-560107** for conducting Elementary **D.Ed. programme** of two and half years duration with an annual intake of 50 students with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in

such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
