WHEREAS, the recognition was granted to the institution namely, Navodaya College of Education, No. 6-2-139/5, Navodaya Nagar, Mantralayam Road, Raichur, Karnataka-584103 run by Navodaya Education Trust, Raichur, Karnataka-584102 vide SRC vide order no. F.SRO/NCTE/B.Ed./2004-2005/8933 dt. 30.11.2004 for conducting secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 14.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.
- 3. AND WHEREAS, AND WHEREAS, the SRC in its 381st meeting held on 31st October & 01st November 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 06.11.2019. The institution has submitted reply on 26.11.2019.
- 4. **AND WHEREAS**, the SRC in its 403rd Meeting held on 18th 19th October 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 03.11.2021. The institution has submitted reply on 25.11.2021.
- **5. AND WHEREAS,** the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 25.11.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution vide Final Show Cause Notice dt. 03.11.2021 was informed that the land is mortgaged with Canara Bank as per certificate dt. 08.07.2004 and the same is not permissible under NCTE Regulations,

- 2014. The institution in its reply dt. 25.11.2021 only mentioned that the land is no more mortgaged with Canara Bank and documents are in society's possession. The institution did not submit sufficient proof for clearance of loan and release of land documents by the bank. The institution had clearly violated the provisions canvassed under clause 8(4)(1) of NCTE Regulations, 2014 which prohibits to mortgage the land.
- 2. The institution submitted a copy of sale deed whereas the Encumbrance Certificate No. 19 6-2-139/5 submitted for the land on "Lease" and further the name of claimants in EC is shown as "ICICI Bank Hubli a Branch Manager".
- 3. The institution did not submit faculty duly approved by the affiliating body for D.El.Ed. course.
- 4. The area of multipurpose hall is shown as 1869.68 sq. mtrs (2012.12 sq.ft.) which is not possible.
- 5. The building plan submitted by the institution is not approved by the competent authority.
- 6. The institution submitted form 'A' issued by the bank for 13 lakhs of FDRs towards Endowment and Reserve Funds but the same is not sufficient for both the courses as per NCTE Regulations, 2014.
- 7. The institution vide Final Show Cause Notice dt. 03.11.2021 was directed to submit consolidated staff list duly approved by the affiliating body after issuance of the notice but the institution submitted a copy of letter issued by the Registrar, Gulbarga University on 24.04.2019 regarding approval of 16 faculty and 8 non-teaching staff alongwith proforma. The proforma is signed by the Registrar, Gulbarga University but the date of approval has not been affixed.
- 8. Other documents such as BCC, LUC and building plan etc. can not be accepted on the face of the deficiency in land documents.
- The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 10. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Navodaya College of Education, No.6-2-139/5, Navodaya Nagar, Mantralayam Road, Raichur-584103, Karnataka for conducting B.Ed. & D.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Navodaya College of Education, No.6-2-139/5, Navodaya Nagar, Mantralayam Road, Raichur-584103, Karnataka run by Navodaya Education Trust, Raichur, Karnataka-584102 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
