WHEREAS, the recognition was granted to the institution namely, Sri Devi Sharada College of Education, Bhandarkars Complex, Kulur Ferry Road, Mannagudda, Mangalore, Karnataka-575003 run by Premakanthi Trust, Mangalore, Karnataka vide SRC vide order no. F.SRO/NCTE/B.Ed./2005-2006/5353 dt. 03.02.2006 for conducting secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. **AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 290th Meeting held on 10th& 11thJuly, 2015 considered the matter and decided to accord permission for change of name of "Sri Devi Sharada College of Education, Bhandarkars Complex, Kulur Ferry Road, Mannagudda, Mangalore, Karnataka-575003" to "Premakanti College of Education, Bhandarkars Complex, Kulur Ferry Road, Mannagudda, Mangalore, Karnataka-575003". Accordingly, a change of name letter was issued to the institution on 14.09.2015.
- 4. AND WHEREAS, the SRC in its Meeting held on 22nd October 2019 the Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN in all such cases for submitted compliance of RPRO matters. Accordingly, as per decision of SRC a First Show Cause Notice was issued to the institution on 30.10.2019. The institution did not submit reply to the First Show Cause Notice.
- 5. **AND WHEREAS**, the SRC in its 393^{rd} meeting held on $05^{th}-06^{th}$ January, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 19.01.2021. The institution has submitted reply on 10.02.2021.
- **6. AND WHEREAS,** the SRC in its 399^{th} meeting held on $15^{th} 16^{th}$ June 2021 has considered the matter and decided to issue last reminder Letter. Accordingly, as per the decision of SRC, a Reminder Letter was issued to the institution on 29.06.2021. The institution did not submit reply to the last reminder letter.
- 7. AND WHEREAS, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Last Reminder Letter on 29.06.2021. The institution failed to submit reply to the Last Reminder Letter.

Hence, the Committee decided to withdraw the recognition granted to Premakanti College of Education, Bhandarkars Complex, Kulur Ferry Road, Mannagudda, Mangalore, Karnataka-575003 for conducting B.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Premakanti College of Education, Bhandarkars Complex, Kulur Ferry Road, Mannagudda, Mangalore, Karnataka-575003 run by Premakanthi Educational & Charitable Trust, Mannagudda, Mangaluru-575003 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2022-2023 onwards.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
