WHEREAS, the recognition was granted to the institution namely, Rahmans College of Education, H.No. 3-13, Yeshwanthpura Village, Jangoan Mandal, Warangal Dist-506175, Telangana. vide SRC order No. F.AP/NEW/B.Ed/168/SRO/NCTE/2003-2004/645 dated 12.01.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 13.01.2015 for its willingness of two unit in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- **3. ANDWHEREAS**, the SRC vide order no. F.SRO/NCTE/APSO0309/B.Ed./TS/2016-17 dated 01.06.2016 permitted the institution for shifting of premises to new location at Rahmans College of Education (APSO0309) & Rahmans Elementary Teacher Education Institutions (APSO2605), H.No. 3-13, Yeshwanthpura Village, Jangoan Mandal, Warangal Dist-506175, Telangana.
- **4. ANDWHEREAS,** A request received from the institution on 01.08.2016 for one unit. Accordingly, reduction order vide no. F.SRO/NCTE/APSO0309/B.Ed./TS /2016-17/89855 Dt. 12.11.2016 was issued to the institution from 2 units to 1 unit.
- **5. AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue Show Cause Notice to all such institution where compliance/representation has not been submitted by the institution. Accordingly, as per decision of SRC First Show Cause Notice was issued to the institution on 19.11.2019. the institution has submitted its reply on 23.12.2019.
- **6. AND WHEREAS,** the SRC in its 384th meeting held on 12th & 13th February 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 26.02.2020. The institution has submitted written representation for Final Show Cause Notice on 11.03.2020.
- 7. **AND WHEREAS.** the SRC in its 401st meeting held on 11th 12th August, 2021considered the matter and decided to withdraw recognition. Accordingly, as per decision a withdrawal order was issued to the institution vide order no. F.SRO/NCTE/ APS00309/B. ED/TS/2021 dated 27.08.2021.
- 8. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. File.no. 89-270/E-199219/2021 Appeal/22nd Meeting, 2021 Appeal No. APPLSRC202114128

9. AND WHEREAS, the SRC in its 405th Meeting held on 13th 14th December, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Rahmans College of Education, Survey No. 96/1,3,4, 6, Yeshwanthpura Village, Jangoan Mandal, Warangal District-506175, Telangana for B.Ed. programme for 1 basic units of 50 students."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e Rahmans College of Education, Survey No. 96/1,3,4, 6, Yeshwanthpura Village, Jangoan Mandal, Warangal District-506175, Telangana for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **14.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
