WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **DNR College of Education, Bhimavaram-534202, West Godavari District, Andhra Pradesh** vide SRC (NCTE) order No. F.AP/M.Ed/SRO/NCTE/2002-2003/9903 dated 11.11.2003 for M.Ed. Course of one year duration from the academic session 2003-2004 with an annual intake of 25 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 24.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 31.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 (one basic unit 50 students) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a First Show Cause Notice was issued to the institution on 09.09.2020.

4. **AND WHEREAS**, the SRC in its 389th Meeting held on 12th & 14th October, 2020, and the Committee decided to issue Final Show Cause Notice. Accordingly as per decision Final Show Cause Notice was issued to the institution on 19.10.2020. the institution has submitted reply of final show cause notice on 19.11.2020

5. **AND WHEREAS**, the matter was further considered by the SRC in its 405th meeting held on 13th – 14th December, 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 19.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. *The institution has submitted photocopy of faculty list approved by DEAN Faculty of Education Adikavi Nannaya University. The same shall be approved by the Registrar of the affiliating University.
The institution has not submitted latest consolidated Staff list (D.Ed., B.Ed., M.Ed.) duly approved by the Registrar of the affiliating body as per the prescribed Format.*
2. *The institution did not submit details of administrative and professional staff as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014 for B.Ed. course.*
3. *The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.*
4. *The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.*
5. *The institution has not submitted "Form A" issued by the respective Bank Manager towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs*
6. *The institution has submitted notarized photocopy of land documents, NEC which are in regional language. However English translated copy of the same not submitted by the institution.*
7. *The institution has submitted photocopy of Building Plan but the same is not readable.*

*Hence, the Committee decided to **withdraw the recognition granted to DNR College of Education, Bhimavaram-534202, West Godavari District, Andhra Pradesh** for conducting **B.Ed. & M.Ed.** programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

6. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **DNR College of Education, Bhimavaram-534202, West Godavari District, Andhra Pradesh** for conducting **B.Ed.** programme of two year duration with an annual intake of 50 students (one basic unit) for **M.Ed.** course with effect from the academic session i.e. 2022-2023 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
