**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **Venkateswara College of Education, Near Gayathri Kalyana Mantapa, D. No. 5/145-67-A, Kadiri, Ananthpur – 515591, Andhra Pradesh** run by **Balaji Educational Society, Anantapur 515001**. vide SRC (NCTE) order No. F.SRO/NCTE/B.ED/2006-2007/2147 dated 30.04.2007 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 28.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units 50 students each) from the academic session 2015-16.

**AND WHEREAS**, the SRC in 342<sup>nd</sup> meeting held on 05<sup>th</sup> -06<sup>th</sup> July 2017 considered the matter and decided for reduction of intake from 2 units to 1 unit as requested.

**AND WHEREAS**, the SRC in 387<sup>th</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August 2020 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued and the institution has submitted reply on 30.12.2019.

**AND WHEREAS**, the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> February, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 15.03.2021. the institution has submitted reply of Final Show Cause Notice on 01.04.2021.

**AND WHEREAS**, the SRC in its 405<sup>th</sup> meeting held during 13<sup>th</sup> – 14<sup>th</sup> December, 2021 considered the matter and decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 01.04.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. *The institution was initially granted recognition on rented premises. The institution has submitted Lease Deed dt. Lease Deed – 28.05.2019. In favour*

of – **BALAJI EDUCATIONAL SOCIETY**, with a validity of 5 years commencing from **28.05.2019 to 27.05.2024** S. No. **433-4A, 433-4B, 433-4C, 433-4D, 435-1, 435-2A, 435-2B, 435-2C, 435-2D, 446-6, Extent – 0.78 Cents**. The institution has not shifted to its own permanent premises as per records made available by the institution.

- 2 The institution has submitted notarized copy of Building Plan in which Survey No. not mentioned, approving authority seal in regional language. No information provided regarding separate toilet for male and female student and for PWD.
- 3 The institution did not submit details of administrative and professional staff as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014 for B.Ed. course.
- 4 The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
- 5 The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulation 2014.

Hence, the Committee decided to **withdraw the recognition** granted to **Venkateswara College of Education, Near Gayathri Kalyana Mantapa, D. No. 5/145-67-A, Kadiri, Ananthpur – 515591, Andhra Pradesh** for conducting **B.Ed. programme** with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.”

**NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Venkateswara College of Education, Near Gayathri Kalyana Mantapa, D. No. 5/145-67-A, Kadiri, Ananthpur – 515591, Andhra Pradesh** for conducting **B.Ed. programme** of two year duration with an annual intake of 50 students (one basic unit) for B.Ed. course with effect from the academic session i.e. 2022-2023 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order.
