WHEREAS the recognition was granted to the institution namely Dr. KKRS Gowtham College of Education, Vallivrthipadu Village, Byepass, Rajendranagar, Gudiyada Rural. Krishna District, Andhra Pradesh-521301 run by Sri Gowtham Educational Society. Krishna District, Andhra Pradesh vide SRC (NCTE) order No. F.SRO /NCTE/B.Ed./2006-2007/784 dated 12.04.2007 for conducting Secondary B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 30.01.2015 for its willingness for adherence of provisions of new Regulations. a revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units 50 students each) from the academic session 2015-16.

AND WHEREAS, the institution has submitted a request for closure on dated 14.09.2015 for closer the institution. Accordingly, a letter was issued to the institution on dt 04.11.2015 to apply in the format for closure application, but the reply of institute has not been received.

AND WHEREAS, the SRC in its 405th meeting held during 13th - 14th December 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee agreed to close down the institution as requested by the society vide letter dated 04.01.2015 by withdrawing the recognition granted to Dr. KKRS College of Education, Vallivrthipadu Village, Rajendranagar, Gudivada Rural, Krishna District, Andhra Pradesh-521301 for conducting B.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-23.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition Dr. KKRS Gowtham College of Education, Vallivrthipadu Village, Byepass, Rajendranagar, Gudivada Rural, Krishna District, Andhra Pradesh-521301 for conducting B.Ed. programme of two-year duration with

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
