**ORDER**

WHEREAS the institution namely Sowkhya College of Education, N.H. 17, Bhatkal, Uttara Kannada District, Karnataka-581320 was granted recognition vide order no. F.SRO/NCTE/B.Ed./2004-2005/9123 on dt. 03.12.2004 for B.Ed. course with an annual intake of 100 students for session 2004-2005.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dt. 28.01.2015.

AND WHEREAS, the provisional revised recognition order was issued on dt. 16.05.2015 to the institution for conducting **B.Ed. programme of two years duration with an annual intake of 100 students each for two basic units** from the academic session 2015-2016.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 5.02.2019.

AND WHEREAS, a request letter was received from the institution on dt. 05.03.2019 for continued recognition for one basic unit of two years B.Ed. course.

AND WHEREAS, the SRC in its 375<sup>th</sup> meeting held on 13<sup>th</sup> – 14<sup>th</sup> May, 2019 the matter was placed before the Committee and decided to Withdrawn the recognition of the institution and as per the decision of SRC, a **Withdrawal order** no. F.SRO/NCTE/APSO2152/B.Ed./KA/2019/104630-4636 dated 23.05.2019 was issued to the institution.

AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.91-8<sup>th</sup>/9<sup>th</sup>Mtg. /2020-Appeal/91558 dated 23.07.2020 and the Council remands back the case.

AND WHEREAS, SRC in its 387<sup>th</sup> Meeting held on 24<sup>th</sup> & 25<sup>th</sup> August 2020 the matter was placed before the Committee and decided to issue Final Show Cause Notice to the institution.

AND WHEREAS, as per the decision Final Show Cause Notice was issued to the institution on dt. 01.09.2020.

**AND WHEREAS**, the institution submitted reply of Final Show Cause Notice on dt. 07.10.2020.

**AND WHEREAS**, the compliance submitted by the institution on dt. 07.10.2020 and the matter was considered by the SRC in its 390<sup>th</sup> Meeting held on 28<sup>th</sup> & 29<sup>th</sup> October 2020 as under:

“The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 07.10.2020, the Committee decided that the **continuation order** be issued to the Institution, **Sowkhya College of Education, N.H. 17, Bhatkal – 581320, Uttara Kannada District, Karnataka** for B.Ed programme for 1 basic unit of 50 students.”

**NOW THEREFORE**, the SRC decided to permit the institution **Sowkhya College of Education, N.H. 17, Bhatkal – 581320, Uttara Kannada District, Karnataka** i.e. for B.Ed. course run by **Al-Fatha Muslim Women's Welfare Education, Charitable Trust, Bynddor, Udupi District, Karnataka** for continuation of recognition for B.Ed. course of two-years duration with an intake of 50 students (one basic unit) subject to fulfilment of the following conditions:


- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
  - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

14. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
17. The institution shall make available the list of students admitted on its official website.
18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
