WHEREAS the institution namely U.S.P. College of Education, Kodikurichi-Tenkasi Road, Kodikurichi Village, Tenkasi Taluk, Tirunelveli, Tamilnadu-627804 was granted recognition vide order no. F.SRO/NCTE/B.Ed./2006-2007/6506 on dt. 13.07.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter of the institution was considered by the SRC in its 315th meeting held on 17th - 18th June 2016 wherein the SRC decided to the following: -

- 1. They have already shifted without NCTE approval.
- 2. The title deed is in order.
- 3. Inspection fee not paid.
- 4. LUC is in order.
- 5. Obtain latest EC.
- 6. BCC is not given.
- 7. BP is given. According to that, the built-up area is adequate only for one unit.
- 8. Original FDRs not given.
- 9. Faculty list is not approved and not in format.
- 10. Collect fee and cause inspection.
- 11. Ask VT to collect all relevant documents and assess in particular adequacy of builtup area for B.Ed. (2 units) of the 2014 pattern.
- 12. If the built-up area is not adequate for an intake of 200 (100 + 100) for the 2 new units, we will have to withdraw the recognition given in the RPRO for the 2<sup>nd</sup> unit.

AND WHEREAS, the inspection of the institution was conducted on 22.08.2016.

F-mail : src@ncte-india.org Website: www.srcncte.in AND WHEREAS, the matter was again considered by the SRC in its 377<sup>th</sup> meeting held on 3<sup>rd</sup> & 4<sup>th</sup> July 2019 and decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993.

AND WHEREAS, the Final Show Cause Notice was issued on 16.07.2019 and in compliance the institution has submitted its reply (received on 02.08.2019.

AND WHEREAS, the reply was placed before the SRC in its 380<sup>th</sup> meeting held on 18<sup>th</sup> – 19<sup>th</sup> September 2019. The Committee considered the matter and decided to withdraw the recognition granted to the institution for running B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993.

AND WHEREAS, a withdrawal order was issued on 26.09.2019. The institution preferred an appeal. The Appellate Authority vide order no. F.No.89-475/E-143940/2019 Appeal/3<sup>rd</sup> Mtg.-2020/31st January 2020 dt. 02.03.2020 passed an order, and the operative part of the order are as under: -

"AND WHEREAS, Appeal Committee noted that appellant institution has submitted reply dated 29/07.2019 to the final Show Cause Notice (SCN) dated 16/07/2019. As regards qualifications of S/Sh. V. Muruyan, M.R. Murugesan and Miss M. Vanitha, appellant stated that they have appointed qualified faculty in replacement of the above faculty. Appeal Committee noted that appellant institution is recognised for conducting B.Ed. course since 2007 and since then NCTE Regulations have been revised twice i.e.in 2009 and 2014. More importantly appellant institution is required to submit evidence that it has adequate built up area and right number of faculty qualified as per NCTE norms and approved by the affiliating university. Appeal Committee decided that appellant institution is required to submit to SRC, a B.C.C. indicating the area earmarked for conducting B.Ed. course and list of faculty in prescribed Performa duly approved by the affiliating body within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to SRC for revisiting the matter by taking a holistic view of the case.

AND WHEREAS, after perusal of the Memoranda of Appeal, affidavit, documents on records and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to SRC for revisiting the matter by taking a holistic view of the case.

NOW THEREFORE, the Council hereby remands back the case of U.S.P. College of Education, U.S.P. Nagar, Kodikurichi, Tenksai to Ayikudi Road, Kadayanalur, Tirunelveli, Tamil Nadu to the SRC, NCTE for necessary action as indicated above."

AND WHEREAS, the institution has submitted its reply 17.03.2020.

AND WHEREAS, the compliance submitted by the institution on dt. 17.03.2020 and the matter was considered by the SRC in its 390<sup>th</sup> Meeting held on 28<sup>th</sup> & 29<sup>th</sup> October 2020 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 07.03.2020, the Committee decided that the continuation order be issued to the Institution, U.S.P. College of Education, Kodikurichi-Tenkasi Road, Kodikurichi Village, Tenkasi Taluk, Tirunelveli, Tamilnadu for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e. U.S.P College of Education, 88/2, 90, U.S.P Nagar, Kodikurichi Panchayat, Tenkasi Taluk, Tirunelveli District-627804 for B.Ed. course run by U.S.P Trust, Tirunelveli, Tamilnadu for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

- 14. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 17. The institution shall make available the list of students admitted on its official website.
- 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
