ORDER**

WHEREAS, the institution Adhiparasakthi College of Education, G.B. Nagar, Kalavai-632506, Vellore District, Tamilnadu was granted recognition vide SRC (NCTE) vide order no. F.TN/SEC/SRO/NCTE/2005-2006/4137 of dt. 22.11.2005 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 22.07.2015, the provisional revised recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, as per decision SRC, this it to convey that the inspection letter was issued to the institution on 3.8.2016 but the same has not been conducted. The institution has not submitted compliance of conditions of RPROs in B.Ed. course and the matter of shifting of premise is also unattended/pending.

AND WHEREAS, the matter was placed before the SRC in its meeting 381st held on 31st November 2019 and the committee decided as under:-

"Thereafter, Committee decided to constitute the Visiting Team for inspection of infrastructure & institutional facilities etc for shifting of premises of Adhiparasakthi College of Education G.B Nagar, Kalavai-632506, Vellore District, Tamilnadu."

AND WHEREAS, as per direction of SRC, the inspection was conducted on 30.11.2019 to 01.12.2019 and the VT report received by SRC on 04.12.2019.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 388th Meeting held on 14th & 15th September 2020 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Thereafter, a reply of Show Cause Notice was received on dt. 17.06.2020.

AND WHEREAS, the matter was considered by the SRC in its 391st Meeting held on 03rd November as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Adhiparasakthi College of Education, G.B. Nagar, Kalavai-632506, Vellore District, Tamilnadu for the following courses:-

- (i) *B.Ed - 2 units (50 students each unit).*
- (ii) *M.Ed- 1 unit of 50 students.*

The Committee also decided that the shifting of premises be permitted to the institution at its owned building at Adhiparasakthi College of Education, S. No. 531/2, G.B. Nagar, Mecheri Village & Panchayat, Arcot Taluk, Vellore District, Tamil Nadu.”

NOW THEREFORE, the SRC decided to permit the institution i.e. Adhiparasakthi College of Education, S. No. 531/2, G.B. Nagar, Mecheri Village & Panchayat, Arcot Taluk, Vellore District, Tamil Nadu for B.Ed. course run by Adhiparasakthi Charitable Medical Educational and Cultural Trust for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
10. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
 11. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such

as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
 14. The institution shall make available the list of students admitted on its official website.
 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
