WHEREAS the institution namely A. S. College of Education, Boys Town, Pulluthu Post, Ellis Nagar via, Madurai, Tamilnadu-625010 was granted recognition vide order no. F.SRO/NCTE/B.Ed./2006-2007/10081 on dt. 09.01.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 22.06.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, revised provisional recognition order was issued to the institution on 30.06.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th Meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, as per the decision a Show Cause Notice was issued to the institution on 24.07.2019. The institution has not submitted any documents in response to Show Cause Notice issued on dt. 24.07.2019.

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380th Meeting. The Sub-Committee decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution.

AND WHEREAS, a Final Show Cause Notice was issued on 10.10.2019.

"On the perusal of the records available in the file of the institution the Committee considered the matter of shifting of premise and observe that the institution had not submitted any reply of the Show Cause Notices on dt. 24.07.2019 and 10.10.2019, hence the Committee decided that the institution may be given a final opportunity before withdrawal of recognition u/s 17 of NCTE Act, 1993 for submission of replies of the Show Cause Notices. The institution be specifically directed to submit the reply within a period of 21 days from the issue of Final letter. The letter be also enclosed with copies of both SCNs.

In view of the above, the Committee decided to seek the above documents from the Institution by sending a last reminder letter before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the dater of issue of the letter."

AND WHEREAS, a letter was issued on 21.01.2020 to the institution communicating the decision taken in 383<sup>rd</sup> Meeting.

AND WHEREAS, the institution has submitted its reply on dt. 03.02.2020 & 19.02.2020 along with documents.

AND WHEREAS, the SRC in its 387<sup>th</sup> Meeting held on 24<sup>th</sup> & 25<sup>th</sup> August 2020 has considered the matter of the institution and decided as under:-

- 1. The institution is required to submit the Land Use Certificate duly approved by the competent authority for change of land use for educational purpose.
- 2. The institution is required to submit the latest Encumbrance Certificate duly notarized in English version.
- 3. The institution is required to submit the latest staff list duly approved by the Registrar affiliating University.
- 4. The institute is directed to submit the details regarding where the institution is functioning since 2012.

AND WHEREAS, a reply was received from the institution on dt. 19.10.2020.

AND WHEREAS, the compliance submitted by the institution on dt. 17.03.2020 and the matter was considered by the SRC in its 390<sup>th</sup> Meeting held on 28<sup>th</sup> & 29<sup>th</sup> October 2020 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution A.S. College of Education, Boys Town, Pulluthu Post, Ellis Nasar via, Madurai District, Tamilnadu 625010 for B.Ed. - 2 units (50 students each unit).

The Committee also decided that the shifting of premises be permitted to the institution at its owned building at A.S. College of Education, S No. 177/1, No. 9, Saraswathy Nagar, Kannanur, A. Kokkulam (Post), Usilampatti T.K. Madurai District, Tamilnadu 625514"

NOW THEREFORE, the SRC decided to permit the institution i.e. A.S. College of Education, S No. 177/1, No. 9, Saraswathy Nagar, Kannanur, A. Kokkulam (Post) Usilampatti T.K. Madurai District, Tamilnadu-625514 for B.Ed. course run by Arunachalam Saraswathy Charitable Trust, Old No. 12, New No. 25, 8<sup>th</sup> Cross Street, Shenoy Nagar West, Chennai – 600030 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 15. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 16. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 19. The institution shall make available the list of students admitted on its official website.
- 20. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
