WHEREAS, the institution namely V.S. Isaac College of Education, No.126, Attupakkam Village, Arakkonam, Taluk, Vellore-631051, Tamilnadu was granted recognition for conducting M.Ed. course of one year' duration with an annual intake of 25 students from the academic session 2006-2007 vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2006-2007/13911 dt.01.11.2007. The intake of M.Ed. course was enhanced on the basis of NCTE (amendment) Regulations, 2010 from 25 to 35.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 29.01.2015 and the Revised Provisional Revised Recognition Order was issued to the institution on 25.05.2015 for conducting M.Ed. course of two years' duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, as per the decision a Show Cause Notice was issued to the institution on 26.04.2019. Meanwhile, the institution had filed a W.P.No.20466/2019 for restraining the NCTE from insisting the petitioner to comply the condition of the 2014 Regulations. Here, it is informed that there is no orders/ stay from the Hon'ble Court.

AND WHEREAS, the matter was placed before the SRC in its 380th meeting held on 18th - 19th September 2019 wherein the Committee considered the matter and decided to issue Show Cause Notice u/s 17 of NCTE Act.

AND WHEREAS, a Final Show Cause Notice was issued to the institution on 09.10.2019.

AND WHEREAS, the institution has submitted its reply on 31.10.2019 in respect of SCN issued above.

AND WHEREAS, SRC in its 382nd Meeting of the SRC held on 26th & 27th November 2019 and the Committee considered the matter and decided to Withdraw the Recognition to the institution.

AND WHEREAS, as per the decision Withdrawal Order issued on vide order no. F.SRC/NCTE/APSO1144-B.Ed./APSO9141-B.Ed.-AI/APSO6047-M.Ed./112401-2406 on dt. 04.12.2019 under these grounds: -

- (i) The institution has submitted photocopy of FDRs attached with 'Form A' issued by the Karur Vysya Bank of Rs. 5 Lakhs, Rs. 3 Lakhs. FDRs for B.Ed. and D.T.Ed courses not submitted.
- (ii) Photocopy of staff list was submitted for B.Ed. and M.Ed. course which was not approved by the Registrar of the affiliating body as per the NCTE Regulations. The institute had only submitted a photocopy of letter dt. 25.07.2012 issued by the TTEU regarding approval of 11 faculty members in B.Ed. course out of which C. Jayaseeli, S. Prema, K. Vijayalakshime, J. Valarmathi and T. Pandiyan are not qualified. Further approval of faculty for M.Ed. and D.T.Ed. course have not been submitted.
- (iii) The institution submitted in Regional Language.
- (iv) The institution submitted a photocopy of notarized copy of Land Use Certificate in Regional Language.
- (v) The institution has submitted copy of Sale Deed in favour of S. Isaac Jebakumar, S/O Mr. J. Selvadurai. The institute did not submit originally certified copy of land documents. Further, the land is in the name of an individual.

AND WHEREAS, the Appellate Authority in NCTE vide order dt. 16.09.2020 remanded back the case of the institute to SRC. The operative part of the order is reproduced below: -

"AND WHEREAS, after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing. Appeal Committee concluded to remand back to SRC for revisiting the mater for both M.Ed., B.Ed. & B.Ed. (AI) courses. Appellant institution is also required to submit to SRC (I) Original list of faculties in prescribed format approved by affiliating university, (ii) Original letter of the affiliating University for approving the faculty (iii) FDRs and (iv) Originally certified land documents & other related land documents viz. notarised copy of C.L.U. and Non-encumbrance Certificate etc.

NOW THEREFORE, the Council hereby remands back the case of V.S. Isaac College of Education. Attupakkam, Manjambadi Rly Gate, Arakkonam, Vellore, Tamilnadu for both M.Ed., B.Ed., B.Ed.-AI courses to the SRC, NCTE for necessary action as indicated above."

AND WHEREAS, as per Hearing Committee Instructions, the institution has submitted deficiencies rectified documents on dt. 07.09.2020.

AND WHEREAS, SRC in its 389th Meeting held on 12th & 14th October 2020 the matter was placed before the Committee and decided to issue Final Show Cause Notice to the institution.

AND WHEREAS, as per decision Final Show Cause Notice was issued to the institution on dt. 21.10.2020 for M.Ed.-AI course on dt. 21.10.2020.

AND WHEREAS, a reply of Final Show Cause Notice was received on dt. 22.10.2020 & email dt. 02.11.2020.

AND WHEREAS, the compliance submitted by the institution on dt. 17.03.2020 and the matter was considered by the SRC in its 391st Meeting held on 03rd November 2020 as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution V.S. Isaac College of Education, No.126, Attupakkam Village, Arakkonam, Taluk, Vellore-631051, Tamilnadu for the following courses:-

- (I) B.Ed. 4 units (50 students each unit).
- (II) M.Ed.- 1 unit of 50 students.

NOW THEREFORE, the SRC decided to permit the institution i.e. V. S. Isaac College of Education B.Ed./M.Ed. and V. S. Isaac Teacher Training Institute, S. No. 183/1, 183/2, 183/3, 185/3, 193/8A, 193/8B, @ V. No. 126, Attupakkam Village, Manjambadi Railway Gate, Arakkonam Taluk, Ranipet District, Tamilnadu-631051 for M.Ed. course run by Christian Institute of Professional Education and Religious Trust for continuation of recognition for M.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 17. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 18. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 19. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 20. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 21. The institution shall make available the list of students admitted on its official website.

22. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
