WHEREAS the institution St. John's College of Education, No-27, Avanimoola Ninayagar Koli, Veeravanallur, Tirunelveli- 627426, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRC/NCTE/B.Ed./2009/13330 on dt. 29.05.2009 for conducting M.Ed. course of one year' duration with an annual intake of 25 students from the academic session 2009-2010.

AND WHEREAS, enhancement of intake of 10 seats from existing 25 to 35 is permitted to St. Johns College of Education, St. Johns Educational Trust, 27/1, Street no. 12, Ambasamudram, Veeravanallur, Tirunelveli, Tamilnadu-627426.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 06.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 22.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.

AND WHEREAS, a general decision was taken by the SRC in its 314th meeting held on 27th & 28th May 2016 to cause inspection of such institutions.

AND WHEREAS, letter dt. 10.05.2016 was issued to the institution for causing inspection.

AND WHEREAS, as per the decision of SRC, inspection of the institution was conducted on 10.05.2016

AND WHEREAS, the inspection report received on dt. 13.05.2016.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 388th Meeting held on 14th & 15th September 2020 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, as per the decision a Show Cause Notice was issued to the institution on 23.09.2020.

AND WHEREAS, the institution submitted its reply along with documents on dt. 23.10.2020.

AND WHEREAS, a reply of Show Cause Notice was received on dt. 26.10.2020

AND WHEREAS, the compliance submitted by the institution on dt. 26.10.2020 and the matter was considered by the SRC in its 390th Meeting held on 28th & 29th October 2020 as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt 26.10.2020, the Committee decided that the continuation order be issued to the Institution St. John's College of Education, No 27, Avanimoola Ninayagar Koli, Veeravanallur, Tirunelveli 627426, Tamil Nadu for the following courses:-

- (i) B.Ed. 2 units (50 students each unit).
- (ii) M.Ed.- 1 unit of 50 students."

NOW THEREFORE, the SRC decided to permit the institution i.e. St. John's College of Education, no. 1015/1A, 1015/2B, Veeravanallur Village, At Door no. 26, 27/1, Avanimoola Vinayagar Kovil Street, Town Panchayat, Tamilnadu-627426 for B.Ed. course run by St. John's Educational Trust, Veeravanallur-627426 for continuation of recognition for M.Ed. course of two years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 15. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 16. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.

- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 19. The institution shall make available the list of students admitted on its official website.
- 20. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
