NCTE

WHEREAS, the institution Lavanya College of Education, Ramananada Ashrama, Doddaballapura, Bangalore Rural District, Karnataka -561203 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/8913 dt. 30.11.2004 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 12.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 314th meeting held on 27th to 28th May 2016, decided as under:

"For cases of B.Ed (2 Units) in the existing institution, where RPRO, has been issued, we have to cause inspection to check adherence to the 2014 Regulations. This action will have to be completed by July 2016 so that revised Formal Recognition can be issued w.e.f. 2016-17 to enable them to make admission in time.

Action to check the documents in these cases (about 1885 in number) will take time. Instead of Waiting for that action to be completed for placing them before the SRC, to save time, VT Inspections can straightaway be ordered. VT Inspection Report can be considered along with examination of the documents.

Regional Director is authorized to initiate action accordingly. The institution concerned may be alerted about such action so that they will be prepared to receive the Visiting Teams. They may also be advised to keep in readiness latest approved Faculty Lists for Submission to the VTs."

AND WHEREAS, inspection letter was sent to the institution on 14.06.2016.

AND WHEREAS, on 01.07.2016 a letter is received by this office from the Princip Lavanya College of Education, Ramananda Ashrama, Doddaballapura – 5612 Bangalore Rural District, Karnataka as under: -

"With reference to the above subject, here bring to your kind notice that us

In this Regard I further request you to grant only one unit for B.Ed. college (50) fifty students as there no students available to fill up two units. Kindly oblidge and the needful at the earliest."

AND WHEREAS, the SRC in its 322nd meeting held during 20th& 21st October 2016 considered the matter and decided as under: -

- 1. Request for reduction of intake from 2 units to one unit is accepted.
- 2. Ask them to submit all relevant documents for processing the case for issue of a new FR under the 2014 Regulations for B.Ed (1 unit)
- 3. If documents have already been received, process and put up.

AND WHEREAS, a letter was sent to the institution on 16.11.2016.

AND WHEREAS, on 08.11.2017, the institution has submitted a letter along with documents with a request to reconsider and permit for two units from the academic year 2017-2018 is as under:-

"With reference to the avobe subject & reference stated we had granted for 2 units but we regretted to start up due to various reasons related to norms of NCTE and also the demand for admission was very less at that time. Now we completed our construction work last year 2016 December with well-equipped infrastructure, teaching and non-teaching faculty and also we uploaded MAS for QCI as directed by NCTE, deposited Rs. 1,73,400/- (one lakh seven three thousand and four hundred rupees) as per the new regulations and uploaded Teacher successfully.

Therefore, please give us the permission by reconsidering the earlier SRC meeting proceedings and we request you to cancel the earlier application given for single unit (01/07/2016). And we would be happily to go with 2 units with your kind consideration to serve better our society and nation."

AND WHEREAS, a VIP reference has been received from Shri. D.V. Sadananda Gowda, Minister of Statistics & Programme Implementation, Govt. of India, New Delhi which is forwarded by Dr. S.K. Chauhan, US vide letter No. NCTE-CDN015/86/2018-VIP Section-HQ/68808 dated 03.08.2018

AND WHEREAS, the SRC in its 369th meeting held on 28th January, 2019 considered the matter and decided as under:-

- 1. Title is clear. Land area is adequate.
- 2. LUC is not given.

- 3. EC does not mention the society's name.
- 4. BP is in photocopy. Original is required BP given is illegible, clear BP is required.
- 5. BCC is in order. But built-up area of 1586 sqm is less than the requirement of 2000 sqm.
- 6. FDRs for Rs 3 Lakhs more are required. All FDRs totaling to Rs 12 Lakhs should be in original, in joint account and, with 5-year validity.
- 7. Faculty list is not in order.
 - i) It is required in the prescribed format, with photographs attached and, every page authenticated by the Registrar.
 - ii) Faculty strength of 1+15 (i.e. 1+0+4+8+3) is required.
 - iii) It should give details of marks obtained at PG level.
- 8.1. They originally had one unit of 100. This would have become 2 units of 50 each under the new Regulation. Initially, they opted for only one unit of 50. Now, they want 2 units of 50 each. This change is accepted. Issue a formal order accordingly.
- 8.2. Calculation of built-up area, faculty strength and composition, etc. will be made w.r.t. the 2-unit model.
- 9. Issue SCN accordingly.

AND WHEREAS, Show Cause Notice was issued to the institution on 08.02.2019.

AND WHEREAS, the institution has submitted its reply on 08.03.2019.

AND WHEREAS, the SRC in its 375th meeting held on 13th & 14th May 2019 considered the matter and decided as under:

The Committee decided to issue Show Cause Notice asking therein to the institution to submit the following documents/details: -

- As per BCC, the built-up area is sufficient only for one unit of B.Ed. as per NCTE norms. Not enough for two units.
- Society registration certificate is not submitted.
- Built up area and land area is not mentioned in the affidavit.
- Land use certificate is not submitted.
- Photocopy of building plan submitted is not legible. Approving authority is mentioned in regional language. Total land area, total built up area, date of approval and earmarked area for each course being run in the same premises is not mentioned.
- The seal and signature of Registrar, Bangalore University, Bangalore is not reflected in all pages of staff profile.
- The institution has submitted the photocopy of faculty list is not approved by the Registrar of the affiliating University, not as per NCTE norms (1+15). Approval letter of the staff list from the affiliating university is not submitted.

- Sl. No. 3 not having 55% in M.Sc.
- Sl. No. 6 not having 55% in M.Ed.

- School/ Teaching subject not mentioned in the faculty list.
- Faculty for physical education, performing arts and fine arts not appointed.
- Original FDRs of Rs. 5+7=12 lakhs not submitted.
- EC is in regional language.

AND WHEREAS, Show Cause Notice was issued to the institution on 23.05.2019.

AND WHEREAS, the institution vide letter dated 12.06.2019 submitted its reply to the Show Cause Notice.

AND WHEREAS, the SRC in its 386th meeting held on 23rd & 24th July 2020 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, Final Show Cause Notice was issued on 05.08.2020.

AND WHEREAS, the institution vide letter dated 07.09.2020 submitted its reply to Final Show Cause Notice.

AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October 2020 and considered the matter as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN) dated 05.08.2020. The institution has submitted its reply on 07.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution was informed and directed to submit the land use certificate but vide its reply dated 07.09.2020, the institution submitted that the LUC is under process in the Municipality. Accordingly, the LUC has not been submitted even after issuance of Final Show Cause Notice.
- 2. Photocopy of Building Plan submitted is not approved by the competent authority. The building plan does not show survey no., built-up area and site area.

- 3. The size of multipurpose hall is less than the requirement of NCTE Regulations, 2014.
- 4. The deficiency of Faculty communicated vide Final Show Cause Notice has not been removed as in its reply dt 07.09.2020 the institution had mentioned that the approval of faculty is under process in the University.

NOW THEREFORE, the Committee decided to withdraw the recognition granted to Lavanya College of Education, Ramananda Ashrama, Doddaballapura-561203, Bangalore Rural District, Karnataka for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
