WHEREAS, The institution namely **Shri Vidya Mandir College of Education, gurusamy Palayam, Rasipuram Taluk, Namakkal District – 637403, Tamil Nadu** was granted recognition for conducting (M.Ed.) course of one year duration with an annual intake of 25 students SRC, NCTE order dt 20.10.2008 (P-294/Coors.). The enhancement of intake from existing 25 to 35 was permitted on 01.09.2010 (P-296/C).

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has not submitted affidavit for its willingness of M.Ed. course and adherence of provisions of new Regulations.

As a result, the revised provisional recognition order was not issued to the institution.

1. The SRC in its 294th meeting held on 14th – 16th November 2015 decided to issue a Show Cause Notice to seek clarification that institution has not yet submitted an Affidavit for adherence of provisions of new Regulations. Accordingly, a Show Cause Notice was issued to the institution on 20.05.2016. **The institution has not submitted any reply in respect of notice dt 20.05.2016.**
2. The matter of non – submission of reply of Show Cause Notice was placed before the SRC in its 380th meeting held on 18th – 19th September 2019. The Committee considered the matter and decided to issue final show cause notice.

AND WHEREAS, a Final Show Cause Notice was issued on 26.09.2019. **The institution has not submitted any reply till date.**

AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October 2020 and considered the matter as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN) dated 26.09.2019.

1. The institution has failed in submission of written representation along with all required documents in response to Final Show Cause Notice.
2. The institution has also not submitted an Affidavit for adherence of new Regulations, 2014 and Provisional Revised Order for M.Ed. course was not issued.



NOW THEREFORE, the Committee decided to **withdraw the recognition** granted to **Shri Vidya Mandir College of Education, gurusamy Palayam, Rasipuram Taluk, Namakkal District – 637403, Tamil Nadu** for conducting M.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE’s website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
