**WITHDRAWAL ORDER**

**WHEREAS** the institution namely **St. Mark's College of Education, Madukkarai Village, Coimbatore- 614405, TamilNadu** was granted recognition of **B.Ed. course** of one-year duration with an annual intake of 100 students vide order dt.17.12.2007.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014; the institution has submitted affidavit dt.10.03.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

**AND WHEREAS**, Revised Provisional Recognition Order was issued to the institution on 21.04.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

**AND WHEREAS**, Consequent upon the decision taken by the SRC in its 369<sup>th</sup> meeting held on 28<sup>th</sup>, January 2019, a Show Cause Notice u/s 17 of NCTE Act was issued on 31.01.2019. The institutions has submitted a letter dt. NIL received in SRO on 08.05.2019, starting that they're submitting requisite documents as asked through Show Cause Notice. But the document was not attached with the letter.

**AND WHEREAS**, the Sub-Committee constituted by the SRC and as per its decision taken in 380<sup>th</sup> Meeting. The Sub-Committee decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution.

**AND WHEREAS**, Final Show Cause Notice was issued to the institution on dt. 11.03.2020.

**AND WHEREAS**, Both Show Cause Notice and Final Show Cause Notices are un-replied.

**AND WHEREAS**, the SRC in its 389<sup>th</sup> meeting held on 12<sup>th</sup> & 14<sup>th</sup> October 2020 and considered the matter as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN) dated 11.03.2020.


1. The institution has failed in submission of written representation along with all required documents in response to Final Show Cause Notice.

**NOW THEREFORE**, the Committee decided to **withdraw the recognition** granted to **St. Mark's College of Education, Madukkarai Village, Coimbatore- 614405, Tamilnadu** for conducting **B.Ed** course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org), with 60 days from the date of issue of this order.
