WITHDRAWAL ORDER

WHEREAS, the institution B.V.V.S. Dept of P.G. Studies & Research Centre in Education, B.V.V.S. Campus Raichur-Belgaum Road, Bagalkot District-587101, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed/2008/7353 dated 26.11.2008 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

AND WHEREAS, the consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order dt. 24.08.2010.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution on dt. 12.01.2015 and the provisional revised recognition order was issued on dt. 26.05.2015 to the institution for conducting M.Ed. course of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice by issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued to the institution on 30.04.2019.

AND WHEREAS, the institution vide letter dated 22.05.2019 submitted its written representation as under:-

“With reference to the subject cited above, I would like to submit the facts for your kind notice that the revised recognition orders were issued to our institution for conducting M.Ed programme of two years duration from the academic year 2015-16 with an annual intake of 50 students (1 unit) from the academic year 2015-16. It has been decided to permit the institution an intake of one unit of 50 students subject to the institution fulfilling the only condition, i.e., the institution should submit revalidated FDRs of the enchased values in joint account with SRC. Accordingly, FDRs submitted by the college are endorsed by NCTE on 30.07.2015. Now we are enclosing revalidated FDRs for your kind perusal.

Now as per your Show Cause Notice, Condition-I is fulfilled as said above. The Condition-II, condition-III & condition-IV is not applicable for our institution, as we have taken only one unit of 50 students. This is your kind information.”

AND WHEREAS, the SRC in its 377th meeting held on 03rd & 04th July 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, Final Show Cause Notice was issued on 15.07.2019. The institution did not submit its reply to the Final Show Cause Notice till date.

AND WHEREAS, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided as under: -

“The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN) dated 15.07.2019.

1. The institution has failed in submission of written representation along with all required documents in response to Final Show Cause Notice.

Hence, the Committee decided to **withdraw the recognition granted to B.V.V.S. Dept of P.G. Studies & Research Centre in Education, B.V.V.S. Campus Raichur-Belgaum Road, Bagalkot District-587101, Karnataka** for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.”



NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraws recognition B.V.V.S. Dept of P.G. Studies & Research Centre in Education, B.V.V.S. Campus Raichur-Belgaum Road, Bagalkot District-587101, Karnataka was granted recognition vide SRC (NCTE) order no. order no. F.SRO/NCTE/M.Ed/2008/7353 dated 26.11.2008 for conducting M.Ed. course of one-year duration with an annual intake of 25 students from the next academic session starts after issuance of this order.**

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through “Online mode” available on NCTE’s website www.ncte-india.org, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
