WHEREAS, the institution Cauvery B.Ed. College, No.3/1, Kodigehalli Main Road, Sahakaranagar, Bangalore-560092, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/8802 dt.29.11.2004 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 27.11.2015, the provisional revised recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the institution submitted written representation regarding the admitted students for one basic unit dt. 05.11.2015. The matter was placed before the SRC in its 381st meeting held on 31st October - 01st November 2019 considered the matter and decided to issued SCN in all such matter where the institution has not submitted the requisite documents/ VT Report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, First Show Cause Notice was issued to the institute vide dated 30.10.2019. The institute has submitted its reply along with documents vide dated 18.11.2019.

AND WHEREAS, the matter was placed before the SRC in its 388th meeting held on 14th -15th September, 2020 and the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice. Accordingly, in compliance of the above SRC decision, a Final Show Cause Notice was issued to the institution dated 21.09.2020. The institute has submitted its reply on 31.12.2020.

AND WHEREAS, the matter was considered by the SRC in its 393rd Meeting held on 5th-6th January 2021 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Cauvery B.Ed College, No. 3/1, Kodigehalli Main Road, Sahakaranagar, Bangalore - 560092, Karnataka for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, the SRC decided to permit the institution i.e., Cauvery B.Ed. College, No.3/1, Kodigehalli Main Road, Sahakaranagar, Bangalore-560092, Karnataka for B.Ed.

course run by Cauvery Social & Education Trust, Bangalore, Karnataka for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.

- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
