WITHDRAWAL ORDER

WHEREAS, the institution **Sri Ganga Parameshwari B.Ed. College, No. 1/1/58, Railway Station Road, Chittapur, Gulbarga District, Karnataka** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2005-2006/5042 dated 30.12.2005 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2005-2006.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the duration of the B.Ed. course was increased from one year to two years and the existing institutions offering B.Ed. course, of one-year duration, were required to give their acceptance, in the form of an affidavit, for adherence of the NCTE Regulations, 2014.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 30.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 18.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16**. The institution has submitted its written representation on 30.07.2015 and 20.07.2016.

AND WHEREAS, the SRC in its 321<sup>st</sup> meeting held on 28<sup>th</sup>-30<sup>th</sup> September 2016 considered the matter and decided as a SCN was issued to the institution. Accordingly, Show Cause Notice was issued on 14.10.2016. The institution did not submitted reply to the Show Cause Notice till date.

AND WHEREAS, the SRC in 381<sup>th</sup> meeting held on 31<sup>st</sup> Oct & 1<sup>st</sup> Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, Final Show Cause was issued on 31.08.2020.

AND WHEREAS, the matter was placed before the SRC in its 393<sup>rd</sup> meeting held on 5<sup>th</sup> – 6<sup>th</sup> January, 2021 considered and decided as the following grounds:

**"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:**

The Committee considered the reply submitted by the institution on 24.09.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

1. The institution has not submitted certified copy of land document.
2. Diverted area is not mentioned in Land Use Certificate.
3. The Building plan submitted by the institution is not approved by the competent authority. Multipurpose hall area is not readable in the building plan.
4. Site plan is not submitted by the institution duly approved by the competent authority.
5. The Multipurpose hall size is not mentioned in BCC submitted by the institution.
6. The institution has submitted a proforma of faculty wherein the faculty for Perspective of Education has not been mentioned/identified. All faculty members are appointed against the Pedagogy subjects.

Hence, the Committee decided to **withdraw the recognition** granted to Sri Ganga Parameshwari B.Ed. College, No. 1/1/58, Railway Station Road, Chittapur, Gulbarga District, Karnataka for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.."

**NOW THEREFORE,** in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraws recognition of Sri Ganga Parameshwari B.Ed. College, No. 1/1/58, Railway Station Road, Chittapur, Gulbarga District, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2005-2006/5042 dated 30.12.2005 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the next academic session starts after issuance of this order.**

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org), within 60 days from the date of issue of this order.
