ORDER

WHEREAS, the institution Sri Jagadguru Gurubasaveshwara College of Education, Sri Jagadguru Murugha Rajendra Maha Samsthana, Murugha Mutt. Achapura, Anandapura, Sagar Taluk, Shimoga-577412, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/9579 dated 24.12.2004 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 20.01.2015, the provisional revised recognition order was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

AND WHEREAS, the SRC in its 314th meeting held on 27th & 28th May, 2016 the SRC taken general decision to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 13.06.2016 and the inspection was conducted on 19.10.2016. The institution has submitted an application vide letter dated 06.04.2016 and 20.03.2017 requesting therein for reduction of strength from 2 units to 1 unit in its B.Ed. course. The above matter was placed before the SRC in its 344th meeting held on 01st and 2nd August, 2017 and the committee decided to reduce the intake from 2 units to 1 unit. As per the decision, a letter was issued to the institution for reduce 2 units to 1 unit vide dated 09.09.2017.

AND WHEREAS, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October, 2019. The Sub-committee noted that institution have not submitted requisite documents or only part only has been submitted. Further the Committee also decided that First Show Cause Notice be issued to all such institutions if there are some deficiency/ lapses in the documents. Accordingly, First Show Cause Notice was issued to the institution on 04.11.2019.

AND WHEREAS, the matter was again placed before the SRC in its 381st meeting held on 31st October – 01st November, 2019 and 387th meeting held on 24th & 25th August, 2020 the Committee considered the matter and decided to issue Final Show Cause Notice in all such matters where the institution has not submitted. Accordingly, Final Show Cause Notice was issued to the institution on 10.09.2020. Now, it is pertinent to report that the institution has not submitted any replies of above-mentioned Final Show Cause Notice issued in respect of B.Ed. course till date.

AND WHEREAS, the matter was placed before the SRC in its 391st meeting held on 03rd November 2020. The Committee considered the matter and decided to issue Last Reminder Letter to submit the representation to the conditions mentioned in Final Show Cause Notice dt

10.09.2020. As per the decision of the 391st meeting uploaded on the website, the institution has submitted its representation to the SRC on 28.10.2020.

AND WHEREAS, the matter was considered by the SRC in its 393rd Meeting held on 5th-6th January 2021 as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Sri Jagadguru Gurubasaveshwara College of Education, Sri Jagadguru Murugha Rajendra Maha Samsthana, Murugha Mutt. Achapura, Anandapura, Sagar Taluk, Shimoga-577412, Karnataka for B.Ed programme for 1 basic unit of 50 students."

NOW THEREFORE, the SRC decided to permit the institution i.e., **Sri Jagadguru Gurubasaveshwara College of Education, Survey No. 57/1, Sri Jagadguru Murugha Rajendra Maha Samsthana, Murugha Mutt. Achapura, Anandapura, Sagar Taluk, Shimoga-577412, Karnataka for B.Ed. course run by Sri Jagadguru Gurubasaveshwara Vidyapeeta, Shimoga-577412, Karnataka for continuation of recognition for B.Ed. course of two years duration with an annual intake of 50 students (one basic unit)** subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
10. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land,

building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
 13. The institution shall make available the list of students admitted on its official website.
 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
Also order that a copy of this Order be published in the official Gazette.
