ORDER 122400-2406

WHEREAS, Sharana Basaveshwara Vidya Vardhaka Sangha, Gulbarga, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Godutai College of Education for women, S.No.2216/1, Sharana Basaveshwara Temple Campus, Gulbarga-585103, Karnataka for Secondary (B.Ed.) Course of one year duration from the academic session 2005-06 with an annual intake of 100 students and was granted recognition on 21.12.2005 with condition of shift to its own premises/building within three years from the date of recognition (in case the course started in rented premises).

AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.

AND WHEREAS, on 19.01.2015, the institution has submitted an affidavit for offering B.Ed course with an intake of 100 students. The revised order was issued to the institution on 16.05.2015 with an intake of 100 students (two basic units of 50 each).

AND WHEREAS, the institution has submitted revised order reply on 01.07.2015 and 26.10.2015. As per the decision of SRC in its 314^{th} meeting, a letter was issued to institution on 22.06.2016 for inspection.

AND WHEREAS, the institution has submitted inspection fees of Rs. 1,50,000/- vide DD No 239174 dated 08.07.2016. Accordingly, VT members names were generated through online VT module for inspection during the period 27.10.2016 to 16.11.2016. Inspection of the institution was conducted on 09.11.2016 and the VT report along with documents received on 15.11.2016.

AND WHEREAS, the above matter was placed before the SRC in its $351^{\rm st}$ meeting held on $28^{\rm th}$ & $29^{\rm th}$ December 2017. The SRC committee considered the matter and decided to issue a letter to the institution.

AND WHEREAS, a letter was issued to the institution on 09.01.2018. The institution has submitted a letter received in SRC office in 28.01.2019. The matter was placed before the SRC in its 374^{th} meeting held on 09^{th} – 10^{th} April, 2019 considered and decided to issue a SCN to the institution. Accordingly, a Show Cause Notice was issued to the institution vide dated 30.04.2019.

AND WHEREAS, the SRC in its 388th meeting placed the matter and decided as a general decision was considered, a Final Show Cause Notice was issued to the institution. Accordingly, a Final Show Cause Notice was issued to the institution vide dated 12.10.2020 and dated 05.01.2021.

AND WHEREAS, the matter was placed before the SRC in its 393^{rd} meeting held on 5^{th} – 6^{th} January, 2021 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Godutai College of Education for women, Sharana Basaveshwara Temple Campus, Gulbarga 585103, Karnataka for B.Ed programme for 2 basic units of 50 students each unit."

NOW THEREFORE, this order is issued permitting the institution i.e. **Godutai College** of Education for women, S.No.2216/1, Sharana Basaveshwara Temple Campus, Gulbarga-585103, Karnataka for continuation of recognition for B.Ed programme for 2 basic units of (50 students each unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.

- 2. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 4. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 5. The institution shall make available the list of students admitted on its official website.
- 6. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
