WITHDRAWAL ORDER

WHEREAS, the institution **Royal College of Education, S.No.232/35, 8th Main, Byrasandra Road, 1st Block, Jayanagar, Bangalore-560001, Karnataka** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/9216 dated 09.12.2004 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2005-2006.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the duration of the B.Ed. course was increased from one year to two years and the existing institutions offering B.Ed. course, of one-year duration, were required to give their acceptance, in the form of an affidavit, for adherence of the NCTE Regulations, 2014.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 29.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 27.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

AND WHEREAS, the SRC in its 315th meeting held on 17th-18th June 2016 considered the matter and decided to issue a letter to the institution. Accordingly, a letter was sent to the institution on 12.07.2016. The institution has not submitted its reply to the letter till date.

AND WHEREAS, the status of issuance of Show Cause Notice/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd October 2019. The sub-committee noted that the institutions have not submitted requisite documents or only part reply has been submitted. The committee decided to issue Show Cause Notice to the institution. Accordingly; First Show Cause Notice was issued on 24.10.2019. The institution did not submitted reply to the First Show Cause Notice till date.

AND WHEREAS, the SRC in its 381st meeting held on 31st October-01st November 2019 and 387th meeting held on 24th-25th August 2020 decided that a Show Cause Notice by issued in all such matters which have not complied with the conditions mentioned in the RPRO. Accordingly, Final Show Cause Notice was issued to the institution on 07.09.2020. The institution did not submit its reply to the Final Show Cause Notice till date.

AND WHEREAS, the matter was placed before the SRC in its 393rd meeting held on 5th – 6th January, 2021 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

- 1. The institution has not submitted any representation in response to the Final Show Cause Notice issued to the institution on 07.09.2020.**

Hence, the Committee decided to **withdraw the recognition** granted to **Royal College of Education, Uttarahalli Main Road, Bangalore-560061, Karnataka** for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraws recognition of Royal College of Education, S.No.232/35, 8th Main, Byrasandra Road, 1st Block, Jayanagar, Bangalore-560001, Karnataka was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/9216 dated 09.12.2004 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the next academic session starts after issuance of this order.**

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website www.ncte-india.org, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
