#### WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely Krantiveer Sangolli Rayanna College of Education, CTS-10627, Nehrunagar, Belagavi-590010, Karnataka run by Krantiveer Sangolli Rayanna College of Education, Nehrunagar, Belagavi- 590010, Karnataka vide SRC (NCTE) order no. F.KAR/B.Ed/27/SRO/NCTE/2000-2001/1241 for conducting B.Ed. course of oneyear duration with an annual intake of 100 students from the academic session 2000-2001.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the duration of the B.Ed. course was increased from one year to two years and the existing institutions offering B.Ed. course, of one-year duration, were required to give their acceptance, in the form of an affidavit, for adherence of the NCTE Regulations, 2014.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 29.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was placed in 348th Meeting of SRC on 5th & 6th December 2017. The committee considered the matter and decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued on 12.12.2017. A letter was sent to the institution regarding VT inspection on 13.06.2016. Accordingly, as per the direction of the SRC the inspection was conducted on 13.11.2016 and the VT Report received in this office on 15.11.2016.

AND WHEREAS, the SRC in its 381<sup>st</sup> meeting decided to issue Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 06.11.2019. The institution vide letter dated 26.11.2019 submitted its reply to the show cause notice along with the documents.

AND WHEREAS, the above reply was placed before the SRC in its 383<sup>rd</sup> meeting held on 07<sup>th</sup> – 09<sup>th</sup> January 2020. The Committee considered the matter and decided to issue Final Show Cause Notice to the institution to submit the representation to the conditions mentioned therein. Accordingly, a Final Show Cause Notice was issued to the institution on 16.01.2020. The institution has submitted its reply along with the following documents on 06.02.2020.

AND WHEREAS, the matter was placed before the SRC in its  $393^{rd}$  meeting held on  $5^{th}$  –  $6^{th}$  January, 2021 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee considered the reply submitted by the institution on 06.02.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The Building Plan submitted with the latest reply differs regarding Multipurpose hall size from the previously submitted Building Plan.
- 2. The institute has submitted the faculty list approved by the Registrar, Rani Chinnamma University on 05.11.2016. The institute failed to submit Latest faculty approved by the affiliating body.
- 3. As per the letter no. 8-2/98 (CPP-1) dt. 25.06.2003, the institution is running Arts College, High School and B.Ed College in the same campus. But the institution did not submit the earmarked Building Plan for each programme.

Hence, the Committee decided to withdraw the recognition granted to Krantiveer Sangolli Rayanna College of Education, Nehrunagar, Belagavi- 590010, Karnataka for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Krantiveer Sangolli Rayanna College of Education, Nehrunagar, Belagavi-590010, Karnataka run by Krantiveer Sangolli Rayanna College of Education, Nehrunagar, Belagavi-590010, Karnataka vide SRC (NCTE) order no. F.KAR/B.Ed/27/SRO/NCTE/2000-2001/1241 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a>, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
