WITHDRAWAL ORDER

WHEREAS the institution namely V.P. Muthaiah Pillai Meenakshi Ammal College of Education for Women, Viluppanur Village, Karishnankoil, Srivilliputtur Taluk, Virudhunagar District, Tamilnadu-626125 was granted recognition vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/4053 dt. 17.11.2005 of B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 27.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, Revised Provisional Recognition Order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the institution submitted compliance against RPRO matter on dt. 18.11.2015.

AND WHEREAS, the matter was placed before in 314^{th} meeting of SRC held on 27^{th} & 28^{th} May 2016 wherein a general decision was taken to cause inspection of such cases.

AND WHEREAS, as per the decision of SRC, a letter for inspection was sent on 22.06.2016, but inspection was not conducted.

AND WHEREAS, on the basis of decision taken by the SRC in its 375th Meeting held on 13th & 14th May 2019, a Show Cause Notice was issued to the institution on dt. 27.05.2019 with the direction to submit compliance of RPRO.

AND WHEREAS, the SRC in its 393rd Meeting held on 05th & 06th January 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 03.06.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institution has submitted photocopy of Building Plan which is not legible. The size of the classrooms and multipurpose hall is not clear / readable. The total built up area and approving authority is also not clear / readable.
- 2. The institution has submitted notarized NEC wherein the land was shown as "Agricultural Land".
- 3. The institution has not submitted BCC in prescribed format. Also, the same is not approved by the competent authority.
- 4. The institution has not submitted Form A issued by the respective Branch Manager of the notarized Bank towards creation of Endowment and Reserve Fund as per NCTE Regulations, 2014. The photocopy of FDR of Rs 12 lakh submitted by the institution has already matured on 29.07.2020.
- 5. The faculty of the institution is not approved by the affiliating university.
- 6. The website of the institution is not working."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to V.P. Muthaiah Pillai Meenakshi Ammal College of Education for Women, Villuppanur Village, Krishnakoli, Srivilliputtur Taluk, Virudhnagar District, Tamil nadu – 626125 for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, the Committee decided to withdraw the recognition granted to St. Mark's College of Education, Madukkarai Village, Coimbatore- 614405, Tamilnadu for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
