**WITHDRAWAL ORDER**

**WHEREAS** the institution namely **Holy Trinity College of Education, Edaicode Post – 629152, Kanyakumari District, Tamil Nadu** was granted recognition for conducting **(B.Ed.)** course of one-year duration with an annual intake of 100 students SRC, NCTE's order dt 20.06.2007.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the Institution has submitted affidavit dt. 19.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, provisional revised recognition order was issued to the institution on 12.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-16.**

1. The SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 16.09.2019. The institution has submitted its reply on 04.11.2019.
2. The grounds / lapse of disaffiliation of TEIs communicated vide e-mail dt. 11.02.2020 are placed on the table of the Committee along with the original files. The institution along with regulatory file was placed before the SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> – 13<sup>th</sup> February 2020 and the Committee decided as under: -

*"The email received from the Registrar, TNTEU Chennai dt 11.02.2020, the Committee resolved to serve Final Show Cause Notice to all the institution informing the reasons foot forth by the university for each college".*

Accordingly, a Final Show Cause Notice was issued on 10.08.2020.

3. The Committee may please see that the institution had not submitted replies of Show Cause Notice dt 16.09.2019 (RPRO) and Final Show Cause Notice dt. 10.08.2020 (Lapses in affiliation).
4. Additionally, the matter of shifting of premises was taken up at the level of inspection, the VT report was received on 15.09.2016 and the matter is pending for final disposal.

**AND WHEREAS**, the SRC in its 393<sup>rd</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> January 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. **The institution has not responded to the Final Show Cause Notice issued on 10.08.2020.**

**NOW THEREFORE**, the Committee decided to **withdraw the recognition** granted to **Holy Trinity College of Education, Edaicode Post – 629152, Kanyakumari District, Tamil Nadu** for conducting **B.Ed.** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."
