WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Vidhyalaya College of Education, Ayyampalayam post & Village, Thiruvannamalai Taluk, Thiruvannamalai District-606603, TamilNadu run by Vidhyalaya Trust, Thiruvannamalai District, Tamilnadu for B.Ed. Course Vide SRC (NCTE) Order No. F.SRO/NCTE/B.Ed./2006-2007/10060 dated 28.08.2007 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students.

2. AND WHEREAS, an order No.F.No.APSO7609/B.Ed./TN/2012-13/45085 dt.09.08.2012 was issued to the institution to shift its premises to the new location/ building at Vidhyalaya College of Education, Sirunathur Village, Tindivanam Road, Thiruvannamalai District, Pin-604601, TamilNadu.

3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 04.03.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 30.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.

4. AND WHEREAS, the SRC in its 388th meeting held on 14th – 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 04.01.2022. The institution vide letter dated 19.01.2022 has submitted a Show Cause notice in response to the Show Cause Notice.

5. AND WHEREAS, the SRC in its 408th meeting held on 02nd March 2022 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 11.03.2022. The institution vide dated 04.04.2022 has submitted a reply to the Final Show Cause Notice.

6. AND WHEREAS, the SRC in its 425th Meeting held on 18th May 2023 considered the matter and found some deficiencies in reply to Final Show Cause Notice and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 04.04.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.

1. The institution has not submitted latest staff list duly approved by the affiliating body. Further, the institution has failed to submit copies of certificates of academic & professional educational qualification viz. B.Ed. M.Ed., NET, Ph.D etc. and experience certificate of the of the Principal.
2. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
3. The institution failed to submit proof of uploaded information of the Website of the institution as required under clause 7(14) (i), 8 (14) and 10 (3) of the NCTE Regulations, 2014.
4. The institution has not submitted certified/notarized copies of the Land Use Certificate (LUC), hence the same is not acceptable since the institution has submitted a photocopy of the same which cannot be relied.

Hence the recognition granted **Vidhyalaya College of Education, Ayyampalayam post & Village, Thiruvannamalai Taluk, Thiruvannamalai District-606603, TamilNadu for B.Ed. programme** is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing **B.Ed. programme** is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn”.

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Vidhyalaya College of Education, Ayyampalayam post & Village, Thiruvannamalai Taluk, Thiruvannamalai District-606603, TamilNadu** for conducting **B.Ed. Programme** of two years duration of 100 students for two basic units. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

(8. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -




"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
