**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **M.C.T. Teacher Training institute, Melmuri P.O. Pin- 676514, Malapuram District, Kerala** run by **Muslim Cultural Trust, Melmuri Post, District Malapuram, 676514, Kerala** for **B.Ed., B.Ed-AI** programme as per following details:-

- (i) Vide SRC (NCTE) order No F.KL/SEC/08/NCTE/2000-2001/8467 dt. 05.11.2001 for conducting **B.Ed. course** of two year duration with an annual intake of **100** students from the academic session **2001-2002**.
- (ii) Vide SRC (NCTE) order No F.KL/SEC/AI/19/SRO/NCTE/2005-2006/435 dt.19.04.2005 for conducting **B.Ed. Ad. course** of two year duration with an annual intake of **120** students from the academic session **2005-2006**.

**3. AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated **09.03.2015 & 22.01.2015** for its willingness for adherence of provisions of new Regulations.

**4. AND WHEREAS**, a Revised Provisional Recognition Order was issued to the institution on **31.05.2015** for conducting **B.Ed. course** of two years duration with an annual intake of **100 students (two basic units)** from the academic session 2015-2016. A Revised Provisional Recognition Order was issued to the institution on **15.05.2015** for conducting **B.Ed. Ad. course** of two years duration with an annual intake of **100 students (two basic units)** from the academic session 2015-2016.

**5. AND WHEREAS**, a Corrigendum issued vide order **No. F.SRO/NCTE/APSO0645/B.Ed./KL/2015/77116** dated **27.10.2015** permitting the institution to have **one basic unit of 50 students** from the academic session 2015-2016.

**6. AND WHEREAS**, the matter was further considered by the SRC in its **397<sup>th</sup> meeting held on 25<sup>th</sup>-26<sup>th</sup> March, 2021** and the Committee decided as follows:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

The Committee considered the reply submitted by the institution on 25.02.2020 in respect to the Final Show Cause Notice and found the following deficiencies: -

1. The institution has not submitted the Certified Land Documents.
2. As per BCC and demarked area for all teacher training programme build up area is not matched.
3. The institution has submitted photo copy of Certificate instead of 'Change of Land Use' (CLU).
4. The institution has submitted photocopy of NEC in Regional Language.
5. The institution has submitted photocopy of Building plan which is not approved by Competent Authority and Multipurpose hall is not mentioned in Building plan.
6. The institution submitted Site plan is not Approved by Competent Authority.
7. The institute is running three programme (D.El.Ed. B.Ed. & M.Ed.) while the institute has submitted the faculty list for B.Ed. Programme only. The institution has not submitted faculty list for other approved teacher training programme.
8. **The following points noted for B.Ed. Programme:-**
  - (a) **The following faculty not having NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulation 2017 dated 29.05.2017 notified on 09.06.2017.**
    - **Faculty namely Seleena A.A. (Date of appointment 16.08.2017).**
  - (b) **The Lecturer fine Arts/Performing Art and Lecturer on Health Physical Education are not appointed as per F & Q NCTE Regulations, 2014.**
9. The institution has submitted photocopy of Building Completion Certificate.
10. The institution has submitted photocopy of form "A" certificate of 16 lakh. The FDR should be 36 lakh in joint name of institution and SRC NCTE.
11. The institution has not submitted affidavit with reference to SCN point.

Hence, the Committee decided to **withdraw the recognition** granted to **M.C.T. Teacher Training institute, Melmuri P.O. Pin- 676514, Malapuram District, Kerala** for conducting **B.Ed, B.Ed-Ad, M.Ed, D.El.Ed & D.El.Ed-Ad** course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."



2. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby **withdraw the recognition granted to M.C.T. Teacher Training institute, Melmuri P.O. Pin-676514, Malapuram District, Kerala for conducting B.Ed, (one basic unit of 50 students) course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.**"

3. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

4. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
