WHEREAS, the recognition was granted to the KMCT College of Education, Chathamangalm P.O. Kozhikode District, Pin- 673001, Kerala Vide SRC (NCTE) order No F.KL/SEC/N/204/SRO/NCTE/B.Ed./2004-2005/1482 dt. 24.03.2005 for conducting **Secondary course** of one year duration with an annual intake of **100** students from the academic session **2004-2005**.

- 2. **AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated **29.01.2015** for its willingness for adherence of provisions of new Regulations.
- **3. AND WHEREAS,** a Revised Provisional Recognition Order was issued to the institution on **15.05.2015** for conducting **B.Ed. course** of two years duration with an annual intake of **100 students (two basic units)** from the academic session 2015-2016.
- **4. AND WHEREAS,** the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on **03.10.2019**. The institution has submitted vide dated 15.10.2019 received on 18.10.2019.
- 5. **AND WHEREAS,** the matter was further considered by the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> Oct & 15<sup>th</sup>September, 2020 the Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on **23.10.2020** to reply within 21 days. The institution has submitted vide dated 15.12.2020 received on 21.12.2020 & 25.01.2021 received SRC on 21.12.2020
- 6. **AND WHEREAS**, the matter was further considered by the SRC in its **397**<sup>th</sup> meeting held on **25**<sup>th</sup> **26**<sup>th</sup> March ,**2021** and the Committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 21.12.2020 in respect to the Final Show Cause Notice and found the following deficiencies: - Contd.Page/2

2. The institution has submitted Photo copy of Land Utilization Certificate instead

of CLU.

3. The institution has submitted NEC in Regional Language.

- 4. The institution has submitted Building plan in Photocopy. The Multipurpose hall not mentioned the building plan instead of multipurpose hall the building plan shown the seminar hall which is also less Size 1030\*665= 698.52 sq ft which is also less size NCTE norms. The building plan not showing the Separate toilet for PWD and institution campus, building, furniture etc. are barrier free.
- 5. The institution submitted Site plan not Approved by Competent Authority.
- 6. The institution has submitted Building Completion Certificate but not Prescribed format.
- 7. The institution has not submitted form "A" certificate and photocopy of FDRs submitted.
- 8. The institution has not submitted affidavit mentioned in SCN.
- 9. Faculty namely Seena T V is not qualified and possessing less than 55% marks in PG.
- 10. The faculty namely Areefa P M is not qualified as not possessing NET/Ph.D. which is the mandatory requirement for faculty appointed after the date of notification of NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dt. 29.05.2017.
- 11. Principal is not qualified as she do not possess Ph.d.
- 12. The faculties for Fine Arts and Performing Arts (Music/Dance/Theatre) are not appointed.
- 13. The institution has also not provided details of faculty for D.El.Ed. programme, Endowment fund & Reserve Fund for D.El.Ed. programme even after the institution was directed to submit through Show Cause Notice.

Hence, the Committee decided to <u>withdraw the recognition</u> granted to **KMCT** College of Education, Chathamangalm P.O. Kozhikode District, Pin- 673001, Kerala for conducting **B.Ed & D.Ed.** course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 9. **NOW THEREFORE,** in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to to **KMCT College of Education, Chathamangalm P.O. Kozhikode District, Pin- 673001, Kerala** for conducting **B.Ed. course** with effect from the the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- **10.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition

under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
