WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the S.U.M. College of Teacher Education, Mattanur, P.O. Mamba Kannur District, Pin -670611, Kerala Vide SRC (NCTE) order dated 14.02.2006 for conducting B.Ed. course of one year duration with an annual intake of 100 students (two basic units of 50 student each).

- 2. AND WHEREAS, a Revised Provisional Recognition Order (RPRO) was issued to the institution on 20.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016. Subject to fulfilment of the conditions mentioned herein before 31.10.2015
- 3. AND WHEREAS, the matter was Placed before the SRC in its 387^{th} meeting held on 24^{th} 25^{th} August 2020 and decided to issue Show Cause Notice to the institution which have not submitted compliance to the RPRO. Accordingly, a Show Cause Notice was issued to the institution on 15.09.2020.
- 4. AND WHEREAS, the matter was further considered by SRC in its 388th meeting held on 14-15 September 2020. The committee decided to issue Final Show Cause Notice be issued to all such institution. Accordingly, Final Show Cause Notice issued to the institution on 22.02.2021. The institution submitted its reply vide letter dt 03.03.2021 received on 09.03.2021.
- 5. AND WHEREAS, the matter was further considered by the SRC in its 397th meeting held on 25th & 26th March 2021 and the Committee decided as follows:

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee considered the reply submitted by the institution on 09.03.2021 in respect to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institution has not submitted Certified Land Documents.
- 2. The institution has submitted photocopy of Land Use Certificate which is Change of Land Use (CLU) in proper format.

- 3. The institution has submitted photocopy of NEC not approved by Competent Authority.
- 4. The institution has submitted Building Plan in photocopy which is not Approved by Competent Authority and build up area is less than 1500 Sq.mtr and supporting document stated that build up area is 2049.46 on plan paper without any attestation.
- **5.** The institution submitted Site Plan which is not approved by Competent Authority.
- **6.** The institution has submitted incomplete Building Completion Certificate photocopy and also is not approved by Competent Authority.
- 7. The institution has submitted photocopy of form "A" and photocopies of FDRs. The FDRs are not converted into joint account with RD, SRC as required under NCTE Regulations, 2014.
- **8.** The institution has submitted photocopy of faculty list. The Affiliating University letter is not attached. The following points also noted:
 - i. Faculty of Physical Education has appointed on Part time basis.
 - ii. The faculty of fine Arts and performing Art are not appointed.

Hence, the Committee decided to withdraw the recognition granted to S.U.M. College of Teacher Education, Mattanur, P.O. Mamba Kannur Disrict, Pin- 670611, Kerala for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to S.U.M. College of Teacher Education, Mattanur, P.O. Mamba Kannur District, Pin -670611, Kerala for conducting B.Ed. course with effect from academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a val id qualification for purpose of

employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
