WHEREAS, the recognition was granted to the Sree Narayana Gurudeva Training College, Palissery, Poovanthussery Post, Thrissur District-680741, Kerala Vide SRC (NCTE) order No F.SRO/NCTE/B.Ed/2008-09/4457A dt. 30.08.2008 for conducting **B.Ed. course** of one year duration with an annual intake of 100 students from the academic session 2008-2009.

- 2. AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.
- **3. AND WHEREAS,** the institution has not consented to come under NCTE Regulations, 2014 and not submitted the required Affidavit to the effect.
- 4. AND WHEREAS, a show cause Notice dt. 13.10.2020 under section 17 of NCTE was issued to the institution for not consenting to come under NCTE Regulations, 2014 and for non submission of required Affidavit to this effect. The institution did not submitted reply to Show Cause Notice
- 5. AND WHEREAS, the matter was further considered by the SRC in its 388th meeting held on 14th -15th September 2020 and the Committee decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on22.02.2021 to reply within 30 days. The institution has not submitted any compliance against Final Show Cause Notice.
- 6. AND WHEREAS, a letter dated 26.12.2020 was received from the Deputy Registrar, (For The Registrar) University of Calicut as under:-

"A copy of Show Cause Notice issued by NCTE to Sree Narayana Gurudeva Training College, Palissery, Poovathussery Post, Thrissur District-680741, Kerala has been received in this office. In this regard I am to inform you that the Sree Narayana Gurudeva Training College, Palissery, Poovathussery Post, Thrissur District 680741 is not affiliated to the University of Calicut as per records".

7. AND WHEREAS, the matter was further considered by the SRC in its 397th meeting held on 25th -26th March ,2021 and the Committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1) The Deputy Registrar, University of Calicut vide letter dated 26.12.2020 informed that the institution is not affiliated to the University of Calicut as per records.

2) After promulgation of NCTE Regulations, 2014, the institution has not consented to come under NCTE Regulations, 2014 and required Affidavit not submitted by the institution.

3) The institution has not responded to Final Show Cause Notice dated 22.02.2021 issued to the institution. The same returned back with remarks on envelop "RTS Not Known at Poovathussery".

Hence, the Committee decided to <u>withdraw the recognition</u> granted to Sree Narayana Gurudeva Training College, Palissery, Poovanthussery Post, Thrissur District-680741, Kerala for conducting B.Ed course with immediate effect with the direction to the affiliating University that the institution shall not be eligible to run the B.Ed. course after promulgation of the NCTE Regulations, 2014 as the institution failed to comply with the provision of the NCTE Regulations, 2014 and no RPRO order was issued by the SRC, NCTE."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraw the recognition granted to Sree Narayana Gurudeva Training College, Palissery, Poovanthussery Post, Thrissur District-680741, Kerala for conducting B.Ed. course with immediate effect with the direction to the affiliating University that the institution shall not be eligible to run the B.Ed. course after promulgation of the NCTE Regulations, 2014 as the institution failed to comply with the provision of the NCTE Regulations, 2014 and no RPRO order was issued by the SRC, NCTE under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
