WITHDRAWAL ORDER

WHEREAS, the institution was granted recognition namely **Sriman Dharamsingh B.Ed. College, Ambika Nagar, Old. Jeevargi Road, Behind P&T Quarters, Gulbarga, Karnataka-585103** run by **Praveen Education Society, Gulbarga, Karnataka** vide SRC (NCTE) order no. **F.SRO/NCTE/B.Ed./2004-2005/9271** dt. 10.12.2004 for conducting B.Ed. (Secondary) course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, a provisional revised recognition order was issued to the institution on 20.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 with a condition to maintain.**

AND WHEREAS, the SRC in its 316th meeting held during 07th & 08th July 2016 considered the shifting matter and decided to issue a letter to the institution. Accordingly, as per decision a Letter was issued to the institution on 28.07.2016.

AND WHEREAS, the SRC in its 339th meeting held during 22nd & 23rd May 2017 considered the VT report and decided to issue Show Cause Notice to the institution. Accordingly, as per decision a Show Cause Notice was issued to the institution on 05.01.2018.

AND WHEREAS, the SRC in its 374th meeting held on 09th & 10th April 2019 considered the rectification case and Show Cause Notice reply and decided to Withdrawal the recognition of the institution. Accordingly, as per the decision of SRC a Withdrawal order was issued to the institution vide order no. **F.SRO/NCTE/APSO2145/B.Ed./KA/2019/103809-3815** on 26.04.2019.

AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate authority of the NCTE. The Appellate authority vide order no. **F.No.91-26th/27th/28th Mtg./2019-/Appeal/82834** dt. 07.10.2019 and the council remands back the case.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decide to issue Final Show Cause Notice to the institution. Accordingly, as per decision a Final Show Cause Notice was issued to the institution on 08.11.2019.

AND WHEREAS, the institution vide letter dt. 05.12.2019 submitted reply to the Final Show Cause Notice. The SRC in its 390th meeting held on 08th & 29th October 2020 considered the matter and decided to issue last reminder letter to the institution. Accordingly, as per decision a Last reminder letter was issued to the institution on 06.11.2020. The institution vide letter dt. 28.12.2020 submitted its reply to the last reminder letter.

AND WHEREAS, the SRC in its 397th meeting held on 25th & 26th March 2021 considered the matter and decided as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The Committee considered the reply submitted by the institution on 28.12.2020 in response to last reminder letter. The Committee observed the following deficiencies: -

1. The faculty list submitted by the institution is not approved by the affiliating University.
2. As per the unapproved staff list of faculty the institution shown appointment of faculty for Pedagogy subjects only. Faculty in respect of Performing Arts is not appointed.

The Committee also noted that after remanding back the case by the Appellate Authority, the institution was issued **Final SCN** dated 8.11.2019 and in spite of giving sufficient time for removal of deficiency by submission of compliance adhering to norms & standards as per provisions of the NCTE Regulations, 2014, the institution failed to submit the requisite documents.

Hence, the Committee decided to **withdraw the recognition** granted to **Sriman Dharamsingh B.Ed. College, Ambika Nagar, Old Jeevargi Road, Behind P & T Quarters, Gulbarga – 585103, Karnataka** for conducting B.Ed. course with immediate effect under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.”

NOW THEREFORE, the Committee decided to withdraw the recognition granted to **Sriman Dharamsingh B.Ed. College, Ambika Nagar, Old Jeevargi Road, Behind P & T Quarters, Gulbarga – 585103, Karnataka** for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) with immediate effect under clause 17(1) of NCTE Act, 1993.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE’s website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
