WITHDRAWAL ORDER

WHEREAS the recognition was granted to the institution namely, St. Mary's Institute of Elementary Teacher Education, Isukapalem (Highway), Buchireddypalem Post and Mandal, Nellore, Andhra Pradesh-524305 run by St. Mary's Educational Society, Giddalur, Prakasam District, Andhra Pradesh-523357 vide SRC (NCTE) order no. F.SRC/NCTE/D.Ed./2005-2006/2531 dated 26.08.2005 for conducting D.Ed. course of two years duration with an annual intake of 50 students from the academic sessions 2005-2006.

AND WHEREAS, a letter No. RC. No. 359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed Colleges in A.P. since the said managements of Pvt. D.El.Ed Colleges have made admission into the D.El.Ed Course during academic year 2018-19 on their own in violation of Government orders.

AND WHEREAS, the matter was considered by SRC in its 386th meeting held on 23rd-24th July 2020 and decided to issue Show Cause Notice to the institution.

AND WHEREAS, as per the decision of SRC, a Show Cause Notice was issued to the institution on 29.9.2020. Thereafter, the institution has submitted the reply vide dt. 16.10.2020 in response to the Show Cause Notice.

AND WHEREAS, the SRC in its 397th Meeting held on 25th & 26th March 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- 1. The Committee in its 386th meeting after perusal of the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admissions into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders. Accordingly, the SRC decided to issue a Show Cause Notice to all such institutions asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C.No. 359/A/SCERT/2019 dated 29.6.2020.
- 2. In view of the above decision a Show Cause Notice dt 29.09.2020 was issued to the institution and the institution vide letter dated 16.10.2020 has submitted its representation. The Committee noted that the explanation on the observation made by the School Education Department, Govt. of AP is not satisfactory as the institution made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Govt. orders.
